And be it enacted, That when the said gaol shall be completed Old gaol to be and finished, the said commissioners shall, after giving two months notice, sell the old gaol, and the ground on which it stands, to the highest bidder, and execute a deed for the same, and apply the proceeds to the discharge of debts contracted for the building the new gaol, and the surplus if any to be paid to the levy court for the use of the county.

9. And be it enacted, That before the commissioners proceed to Judges to apdirect the erection of the gaol aforesaid, the site selected, and the prove of site plan proposed, shall be approved of by a majority of the judges of before building is erected. CHAPTER 63

An act to establish a Bank and Incorporate a Company under the name of The Bank of Dorchester.

Sec. 1. Be it enacted by the General Assembly of Maryland, That lished. a bank to be called and known by the name of The Bank of Dorchester, shall be established in Cambridge, the capital stock of which shall consist of two hundred thousand dollars, money of the United States, to be divided into shares of fifty dollars each.

2. And be it enacted, That books for the subscription of said opened. stock shall be opened at Cambridge, by the commissioners hereinafter named, or a majority of them, on the first Monday of May next, and the commissioners who shall meet on the day so appointed for receiving the said subscriptions, shall cause the said books to be opened at the place or places agreed upon, at ten o'clock in the morning, and continue the same opened until five o'clock in the afternoon; and if the subscriptions shall exceed the number of shares as above, then the said commissioners are hereby
