Sec. 1. Be it enacted by the General Assembly of Maryland. That CHAP. 195. Ri hard Caton, John Gibson, and others, constituting the said association, their heirs, successors and assigns, be, and they are here- Persons incorpoby declared a body corporate and politic, by the name of The Cape Sable Company, and by that name to have succession until the said company shall be dissolved, by a resolve of three-fourths of the share holders, holding three-fourths of the whole stock of the said company; and the company, and their successors, by the name and title of Cape Sable Company, may sue and be sued, answer and be answered, defend and be defended, in any court of law or equity in this state or elsewhere; they shall have a common scal, and the same may break, alter or change, at their pleasure, they may erect a manufactory or manufactories for the making of allum, and copperas, or any other article or articles, and may raise and sell coal, and any other mineral or fossil; and may sell and dispose of their property, and may mortgage the whole, or any part thereof. with the consent of three-fourths of the stockholders holding three-fourths of the shares, for the securing of any loan or debt, and may use and occupy the same as fully and absolutely as any individual might or could do, if holding and enjoying the same; they may make such by laws, ordinances and regulations, as they please, not contrary to this act, or to the laws of this state or of the United States; and may do and execute any matter or thing necessary in the prosecution of their business, by the name of The Cape Sable Company, that any individual might or could do under the laws of this state, and to do which they are authorised in virtue of this act; Provided always, that the said company shall engage in no other Proviso, manufacture except that of allum and copperas, without the consent in writing of three-fourths of the stockholders holding three-

fourths of the shares.
