2. And be it enacted, That where any person or persons having property situate as aforesaid, shall refuse or neglect to pay such valuation as herein before directed, the commissioners of the said town, or a majority of them, may proceed against such person or persons, in the same manuer, for the recovery thereof, as they are forieitures, &c. directed to proceed for the recovery of forfeitures under the original law to which this is a supplement.
