Senate Bill No. 7—By Senator Phoebus:

A Bill entitled "An Act to repeal and re-enact, with amendments, Section 325 of Article 81 of the Annotated Code of Maryland (1957 Edition), title 'Revenue and Taxes', sub-title 'Retail Sales Tax Act', to increase the rate of the retail sales tax; and to repeal and re-enact, with amendments, Section 373 of Article 81 of the Annotated Code of Maryland (1957 Edition), title 'Revenue and Taxes', sub-title 'Maryland Use Tax', to increase the rate of the use tax; and to repeal and re-enact, with amendments, Section 326 (g) of said Article and sub-title, to provide that the rate of tax imposed on certain farm equipment and vehicles be equal to that imposed on motor vehicles under the titling tax provisions of Section 29 of Article 66 $\frac{1}{2}$ of the Annotated Code of Maryland (1957 Edition)".
