"Alcoholic Beverages", sub-title "Hours and Days For Sale", said section to follow immediately after Section 99 (c) thereof, relating generally to the hours which certain privileges of a Beer, Wine and Liquor License, Class B, may be exercised in Prince George's County.

SECTION 1. Be it enacted by the General Assembly of Maryland, That new Section 99 (d) be and the same is hereby added to Article 2B of the Annotated Code of Maryland (1951 Edition and 1956 Supplement), title "Alcoholic Beverages", sub-title "Hours and Days For Sale", said section to follow immediately after Section 99 (c) thereof, and to read as follows:

## 99. (Prince George's County.)

(d) In Prince George's County notwithstanding any other provisions of this Article, but in addition thereto the holder of a Beer, Wine and Liquor License, Class B, his agents, servants or employees shall not sell any alcoholic beverages for consumption off the licensed premises between the hours of 12:00 midnight and 2:00 A. M. from any separate store established on the licensed premises of AS an "off-sale store" or to keep said "off-sale store" open for business during said hours and for the purpose of this provision, the Board of License Commissioners of Prince George's County shall determine by reasonable standards what shall constitute an "off-sale store". Nothing herein contained shall prohibit the sale of alcoholic beverages for consumption off the licensed premises between 12:00 midnight and 2:00 A. M. of any day except Sunday provided said sale is made from the bar of OR restaurant facilities of said licensed premises.

SEC. 2. And be it further enacted, That this Act shall take effect June 1, 1957.
