

OF CONDUCTING THE AFFAIRS OF SUCH ALMSHOUSE AND THE OFFICERS AND EMPLOYEES THEREOF SHALL BE SUBJECT TO THEIR CONTROL, AND SAID COUNTY COMMISSIONERS SHALL MEET AT SAID ALMSHOUSE AT LEAST ONCE IN EACH MONTH, SHALL AUDIT THE BOOKS THEREOF AND FILE WITH THE CLERK OF THE COUNTY COMMISSIONERS AN ITEMIZED REPORT OF RECEIPTS AND EXPENDITURES FOR THE PRECEDING MONTH; AND ALL ACCOUNTS AND BILLS AGAINST THE SAID ALMSHOUSE SHALL BE VERIFIED BY OATH OF THE PERSON FROM WHOM PURCHASED AND SHALL BE PAID BY DRAFT OF THE CLERK TO COMMISSIONERS ON THE TREASURER OF THE COUNTY, AND SHALL BE COUNTERSIGNED BY THE PRESIDENT OF THE BOARD; AND THE SAID COMMISSIONERS SHALL EACH RECEIVE OUT OF THE AMOUNT LEVIED FOR SAID ALMSHOUSE THE SUM OF FIFTY DOLLARS PER YEAR FOR THE PERFORMANCE OF DUTIES REQUIRED OF THEM BY THIS SUB-TITLE, SAID SUM BEING PAYABLE IN QUARTERLY INSTALLMENTS OF TWELVE AND ONE-HALF DOLLARS EACH.

66. THE COUNTY COMMISSIONERS OF ALLEGANY COUNTY SHALL EACH BE PAID NINE HUNDRED DOLLARS (\$900.00) PER ANNUM, PAYABLE MONTHLY, FOR SERVICES RENDERED AS ROAD COMMISSIONERS OF SAID COUNTY IN ADDITION TO THE COMPENSATION PROVIDED BY SECTION 65. THE ATTORNEY TO THE BOARD OF COUNTY COMMISSIONERS SHALL BE PAID THREE HUNDRED DOLLARS (\$300.00) PER ANNUM, PAYABLE MONTHLY, FOR LEGAL SERVICES RENDERED TO SAID BOARD AS ROAD COMMISSIONERS, IN ADDITION TO THE COMPENSATION PAID HIM AS ATTORNEY TO THE BOARD OF COUNTY COMMISSIONERS.

73. THE CLERK TO THE BOARD OF COUNTY COMMISSIONERS SHALL DO SUCH CLERICAL WORK AS MAY BE DIRECTED BY THE BOARD FROM TIME TO TIME. HE SHALL RECEIVE ANNUAL COMPENSATION IN THE AMOUNT OF NOT LESS THAN FORTY-THREE HUNDRED AND FIFTY DOLLARS (\$4,350.00) WHICH SHALL BE IN LIEU OF ALL OTHER COMPENSATION HERETOFORE RECEIVED.

SEC. 3. *AND BE IT FURTHER ENACTED*, THAT ALL LAWS INCONSISTENT WITH THE PROVISIONS OF THIS ACT BE AND THE SAME ARE HEREBY REPEALED TO THE EXTENT OF SUCH INCONSISTENCY.

SEC. 2. 4. *AND BE IT FURTHER ENACTED*, THAT THE PROVISIONS OF THIS ACT CHANGING THE SALARY OF THE SHERIFF OF ALLEGANY COUNTY SHALL NOT EXTEND OR APPLY TO THE SHERIFF IN OFFICE ON THE EFFECTIVE DATE OF THIS ACT, AND SHALL TAKE EFFECT WITH THE NEXT TERM OF OFFICE.

SEC. 2. 3. 5. *And be it further enacted*, That this Act shall take effect June 1, 1957.
