**173A.**

It shall be unlawful for any person to take or catch fish by means of hook and line ~~or nets~~ on the Susquehanna Flats as that area is defined in Section 165 of this Article, or in the tidal waters of the following tributaries of the Chesapeake Bay, Susquehanna River south of the Pennsylvania Railroad bridge, Mill Creek, Furnace Bay, North East River, Elk River, Bohemia River, Swan Creek, Bush River or Romney Creek ~~within three hundred (300) yards of any licensed duck blind during the period of fourteen days prior to, TWO (2) DAYS PRIOR TO, and extending until the closing day of, the wild waterfowl hunting~~ THE REGULAR DUCKING season as determined and fixed annually by the Federal Fish and Wildlife Service. Nothing herein shall prohibit ice fishing at any time ~~nor shall anything herein prohibit the taking or catching of fish by means of hook, line or nets~~ HOOK AND LINE from the shore line or from docks, or wharves. NOTHING HEREIN SHALL PROHIBIT FISHING BY ANY MEANS WHATSOEVER ON SUNDAYS DURING THE REGULAR DUCKING SEASON.

SEC. 2. *And be it further enacted,* That this Act shall take effect June 1, 1960.

CHAPTER 116

(Senate Bill 56)

AN ACT to repeal and re-enact, with amendments, Sections 330, 332 and 333 of Article 43 of the Annotated Code of Maryland (1957 Edition), title "Health", sub-title "Plumbing", to increase the fees for certain certificates issued by the Board of Commissioners of Practical Plumbing, ~~and~~ increasing the compensation of the members of the Board of Commissioners. AND PROVIDING FOR THE ISSUANCE OF CERTIFICATES TO QUALIFIED APPLICANTS ON A RECIPROCAL BASIS UNDER CERTAIN CONDITIONS.

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That Sections 330, 332 and 333 of Article 43 of the Annotated Code of Maryland (1957 Edition), title "Health", sub-title "Plumbing", be and they are hereby repealed and re-enacted, with amendments, to read as follows:

**330.**

The said Board of Commissioners shall demand and receive from such applicant for a certificate of competency whom they examine
