

or structures, provided that subsequent amendments to any such model or standard code, shall not be effective until specifically incorporated into such building code. IN CHARLES COUNTY THE COUNTY COMMISSIONERS ARE AUTHORIZED TO IMPOSE A FEE FOR ANY PERMIT ISSUED UNDER THE BUILDING CODE AT A COST NOT TO EXCEED ONE DOLLAR PER THOUSAND DOLLARS OF THE TOTAL CONSTRUCTION COST OF THE PROJECT FOR WHICH THE PERMIT IS SECURED. THE COUNTY COMMISSIONERS OF CHARLES COUNTY ALSO ARE AUTHORIZED TO ADOPT AND TO AMEND FROM TIME TO TIME A PLUMBING CODE PROVIDING FOR THE SAFE AND PROPER CONSTRUCTION OF ALL PIPES AND OTHER PLUMBING FIXTURES AND EQUIPMENT IN BUILDINGS AND STRUCTURES LOCATED IN CHARLES COUNTY. THE BUILDING AND PLUMBING CODES IN CHARLES COUNTY SHALL PROVIDE THAT NO PERMIT FOR ANY TYPE OF CONSTRUCTION OR IMPROVEMENT WORK UNDER EITHER OF THESE CODES SHALL BE ISSUED UNTIL THE COUNTY HEALTH DEPARTMENT HAS GIVEN A PRIOR APPROVAL OF THE PLANS FOR THE CONSTRUCTION OR IMPROVEMENT WORK CERTIFYING THAT IN ITS JUDGMENT THE PLANS PROVIDE FOR WORK TO BE DONE WITH SAFETY TO THE PUBLIC HEALTH OF THE PEOPLE OF CHARLES COUNTY.

PROVIDED, HOWEVER, THAT ALL FARM BUILDINGS, AND ALL OTHER OUT-BUILDINGS WITH AN ASSESSED VALUE OF LESS THAN \$1000.00, SHALL BE EXEMPTED FROM THE PROVISIONS AND REGULATIONS OF SAID CODES.

SEC. 2. *And be it further enacted,* That this Act shall take effect June 1, 1959.

## CHAPTER 779

(House Bill 234)

AN ACT to repeal and re-enact, with amendments, Section 2 of Chapter 717 of the Acts of 1955 and to repeal Section 74-55.1 of the Montgomery County Code (1955 Edition, being Article 16 of the Code of Public Local Laws of Maryland), title "Montgomery County", sub-title "Washington Suburban Sanitary District", as enacted by Chapter 78 of the Acts of 1955 and to repeal Section 1590A of the Prince George's County Code (1953 Edition, being Article 17 of the Code of Public Local Laws of Maryland), title "Prince George's County", sub-title "Washington Suburban Sanitary District", as enacted by said Chapter 78 of the Acts of 1955, and to enact in lieu thereof
