

MILES ALONG THE AFORESAID CENTERLINE TO ITS INTERSECTION WITH THE PRESENT CENTERLINE OF THE RIGHT OF WAY FOR THE POTOMAC ELECTRIC POWER COMPANY TRANSMISSION LINE (APPROXIMATELY 800 FEET EAST OF HENSON CREEK) THENCE GENERALLY SOUTHWESTERLY ABOUT 2.0 MILES ALONG THE AFORESAID CENTERLINE TO ITS INTERSECTION WITH THE BOUNDARY LINE OF OXON HILL ELECTION DISTRICT THENCE GENERALLY NORTHEASTERLY ABOUT 2.0 MILES ALONG THE AFORESAID BOUNDARY LINE TO THE PLACE OF BEGINNING.

(2) NOTWITHSTANDING ANY OTHER PROVISIONS OF THE MARYLAND-WASHINGTON METROPOLITAN DISTRICT ACT, NO METROPOLITAN DISTRICT TAX MONEY COLLECTED IN PRINCE GEORGE'S COUNTY AS THE RESULT OF ANY AREA BEING INCLUDED WITHIN THE BOUNDARIES OF THE MARYLAND-WASHINGTON METROPOLITAN DISTRICT SHALL BE EXPENDED FOR THE MAINTENANCE, IMPROVEMENT, ACQUISITION OR PURCHASE OF ANY PARK SITE OR RECREATIONAL AREA BEYOND AND WITHOUT THE BOUNDARIES OF THE SAID MARYLAND-WASHINGTON METROPOLITAN DISTRICT.

(3) NO MUNICIPAL CORPORATION WITHIN THE AREAS ADDED BY THIS SUBSECTION (D) TO THE MARYLAND-WASHINGTON METROPOLITAN DISTRICT SHALL BE AUTHORIZED, BY MEANS OF AN AMENDMENT TO ITS CHARTER OR OTHERWISE, TO EXERCISE ANY OF THE POWERS RELATING TO PLANNING, SUBDIVISION CONTROL AND/OR ZONING NOW OR HEREAFTER GRANTED TO THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION OR THE COUNTY COMMISSIONERS OF PRINCE GEORGE'S COUNTY. IF THIS SUBSECTION SHALL FOR ANY REASON BE HELD BY ANY COURT OF COMPETENT JURISDICTION TO BE INVALID, IT IS HEREBY DECLARED TO BE THE INTENTION OF THE GENERAL ASSEMBLY THAT THIS SUBSECTION WOULD HAVE BEEN ENACTED WITHOUT THE INVALID PORTIONS.

22A BOUNDARIES OF THE UPPER MONTGOMERY COUNTY METROPOLITAN DISTRICT 1959—CREATION OF THE UPPER MONTGOMERY COUNTY METROPOLITAN DISTRICT.

ALL OF THE AREA OF MONTGOMERY COUNTY NOT INCLUDED WITHIN THE MARYLAND-WASHINGTON METROPOLITAN DISTRICT AS IT IS NOW OR MAY HEREAFTER BE DEFINED, WITH THE EXCEPTION OF THE AREA NOW OR HEREAFTER LOCATED WITHIN THE BOUNDARIES OF MUNICIPAL CORPORATIONS AS DEFINED IN ARTICLE 23A, SECTION 9, OF THIS CODE, IS HEREBY ADDED TO SAID MARYLAND-WASHINGTON METROPOLITAN DISTRICT AND IS DESIGNATED THE "UPPER MONTGOMERY COUNTY METROPOLITAN DISTRICT" AND WHICH FOR PURPOSES OF TAXATION SHALL CONSTITUTE A SPECIAL TAXING DISTRICT IN WHICH THE MONTGOMERY COUNTY COUNCIL IS AUTHORIZED TO LEVY ANNUALLY A TAX OF NOT TO EX-
