43. It shall be unlawful for any person or persons, firm or corporation to hold any picnic or camp meeting to which the general public are admitted, without having first obtained a permit from the County Commissioners of Talbot County.

The said County Commissioners are hereby authorized and empowered to issue such licenses and to prescribe such reasonable rules and regulations in connection with their said issue THEREWITH as may seem right and proper, and to require the payment of reasonable fee therefor.

Any person who shall violate the provisions of this Act shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be fined not more than fifty dollars (\$50.00), or imprisoned not more than six months, or both fined and imprisoned in the discretion of the Court.
