

[(5)] (2) For issuing subpoenas for witnesses, for each witness, **[(\$.25)]** \$.50;

[(6)] (3) For issuing every subpoena duces tecum, **[\$.25]** \$.50;

[(7)] For short copy of judgment under seal, \$.50;]

[(8)] (4) For certified copy of docket entries under seal, **[\$1.00]** \$1.50, and for making a certified copy of each block or portion thereof, \$1.50;

[(9)] (5) For certificate under seal of the qualifications of any public official except Justices of the Peace and Notaries Public, **[\$.25]** \$.50;

[(10)] (6) For certificates under seal of the qualification of any Justice of the Peace or Notary Public, **[\$.25]** \$.50;

[(11)] (7) For recording any paper required by law to be recorded, except papers to be recorded in the Land or Chattel Records—**[(for each one hundred words or figures or fraction thereof, \$.15)]** \$2.00 per page or portion thereof;

[(12)] (8) For drawing, empanelling and swearing a jury. **[\$2.00]** \$3.00;

[(13)] For making alphabets and lists of transfers of property for each transfer or index, \$.25;

(14) For recording and extracting all deeds, mortgages or other papers required to be extracted—for each one hundred words or figures or fraction thereof, **[\$.15]**

(9) (i) *For recording all deeds, mortgages or other instruments required to be recorded among the Land Records, \$2.00 per page or portion thereof for recording. In addition thereto the Clerk shall charge the sum of \$.50 per name for each name to be indexed on said instrument, the names of husband and wife to be counted separately. The word "page" as used herein shall be defined as one side of a leaf not larger than 8½ inches wide by 14 inches long.*

(ii) *In Baltimore City or any county where a block system and a grantor-grantee system is maintained for recording of deeds, mortgages or other papers required to be recorded among the Land Records—for each one hundred words or figures or fraction thereof, \$.45 for recording. In addition thereto the Clerk shall charge the sum of \$1.00 per name for each name to be indexed on said instrument, the names of husband and wife to be counted separately. This charge to include indexing both under the block system and the grantor-grantee index:*

[(15)] (10) For recording short releases of mortgages, deeds of trust and of chattel liens of all kinds including releases of conditional contracts of sale, **[\$.75]** \$1.00, plus an indexing charge \$.50 per name where indexing is required. The names of husband and wife to be counted separately;

[(16)] For copying surveyor's photos or recording the same—the same per diem allowed surveyors for making them;]

[(17)] (11) For entering order of satisfaction of judgment on Justices' docket or judgment of the Peoples' Court, **[\$.25]** \$.50;
