SEC. 2. *And be it further enacted*, That this Act shall take effect June 1, 1959.

CHAPTER 360

(House Bill 550)

AN ACT to repeal and re-enact, with amendments, Section 70A of Article 23 of the Code of Public Local Laws of Maryland (1930 Edition), title "Wicomico County", sub-title "Director of Public Works", authorizing the County Commissioners of Wicomico County to appoint a Director of Public Works and defining his qualifications, term of office, duties and compensation.

SECTION 1. *Be it enacted by the General Assembly of Maryland*, That Section 70A of Article 23 of the Code of Public Local Laws of Maryland (1930 Edition), title "Wicomico County", sub-title "Director of Public Works", be and it is hereby repealed and re-enacted, with amendments, to read as follows:

70A. The Board of County Commissioners of Wicomico County is authorized and empowered to appoint as Director of Public Works of Wicomico County a person, *who has graduated with an engineering degree from a college or university having an approved engineering curriculum of four years or more approved by the County Commissioners*; ~~]~~ *duly qualified as a "Registered Professional Engineer"*, as provided in Article 75½ of the Code of General Public Laws of Maryland; ~~]~~ to fix his compensation; to determine the amount of bond which he shall give; and to discharge said Director of Public
