

property or lot is situated, or from any agency or department having zoning or planning powers over the particular area; and, in granting said permit, said county commissioners, zoning agency or department to issue such permit shall have the right to appeal to the circuit court for the county, provided that such appeal is taken within ten days from such refusal. The zoning agency or department of any county shall exercise the powers under this section only while designated to so do by the county commissioners of the particular county. Any person violating the provisions of this section shall be guilty of a misdemeanor and, upon conviction thereof, shall be fined not exceeding twenty-five dollars (\$25.00) for each such violation, and each day on which such violation continues shall be considered a separate offense. The provisions hereof shall apply only to Carroll, Cecil, Charles, Dorchester, Wicomico, Worcester, Harford, Prince George's, Kent and Washington counties. *Provided that in Charles County nothing contained herein shall affect any junk yard, dump, or lot in existence on June 1, 1959.*

SEC. 2. *And be it further enacted,* That this Act shall take effect June 1, 1959.

## CHAPTER 554

(Senate Bill 468)

AN ACT to add a new Section 68A to Article 24 of the Code of Public Local Laws of Maryland (1930 Edition), title "Worcester County", sub-title "County Commissioners", to follow immediately after Section 68 thereof, authorizing the Board of County Commissioners of Worcester County to make a contribution to the cost of constructing a bridge between Assateague Island and the mainland of Worcester County and relating generally to the terms and conditions of such contribution; ; AND AUTHORIZING AND EMPOWERING THE COUNTY COMMISSIONERS OF WORCESTER COUNTY TO IMPOSE A SPECIAL TAX OR ASSESSMENT UPON CERTAIN PROPERTY ON ASSATEAGUE ISLAND THE PROCEEDS OF WHICH MAY BE TREATED AS A SIMILAR AND MATCHING CONTRIBUTION BY THE ASSATEAGUE ISLAND BRIDGE CORPORATION.

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That new Section 68A be and the same is hereby added to Article 24 of the Code of Public Local Laws of Maryland (1930 Edition), title "Worcester County", sub-title "County Commissioners", to follow immediately after Section 68 thereof, and to read as follows:

*68A. In the event the State of Maryland, acting through the State Roads Commission, AND WITH FEDERAL AID, IF AVAILABLE,*
