C H A P. VI.

A Supplement to an act, entitled, An act to empower the justices of the peace of Charles county to assess and levy a sum of money on said county to repair their court-house and build a record-office. Passed December 22.

WHEREAS it is represented to this general assembly, by the justices of Charles county court, that there is wanted the sum of fifty-eight pounds current money to complete the object of the law to which this is a supplement; Preamble.

II. *Be it enacted, by the General Assembly of Maryland,* That it shall and may be lawful for the justices of the peace of Charles county for the time being, and they are hereby authorized, empowered and required, at their next levy-laying court, to levy on the assessable property in said county the sum of fifty-eight pounds current money, together with a commission of six *per centum* for collection, which sum, so assessed, shall be collected by the sheriff, or other person appointed to collect the county levy in said county, as other county levies are collected; and the said sheriff or collector, as the case may be, is hereby required and directed to pay the same to the justices of Charles county court for the time being, who are authorized and required to apply the same to the building and completing a record-office in said county. Justices to levy money, &c.

III. *And be it enacted,* That the justices of the said court for the time being, are hereby authorized and empowered, as soon as the said office shall be completed, to have all the records of the said county, or any part thereof that they may think proper, removed thereto, and deposited therein, for the preservation of the same. And remove the records, &c.

C H A P. VII.

An ACT to enable the inhabitants of All-Faith parish, in Saint-Mary's county, to elect vestrymen and churchwardens for said parish, and for other purposes. Passed December 22.

WHEREAS the inhabitants of All-Faith parish, in Saint-Mary's county, neglected to meet and choose vestrymen and churchwardens for the said parish, agreeably to the act for the establishment of select vestries; Preamble.

II. *Be it enacted, by the General Assembly of Maryland,* That the inhabitants of said parish be and they are hereby empowered to meet at their parish church on Easter Monday next, and there proceed to choose vestrymen and churchwardens, in as ample and full a manner as they would have done under the act aforesaid; and the vestrymen and churchwardens, when so chosen, shall have, and are hereby declared to be vested with, all the power and authority of select vestries under and in virtue of the laws of this state, and shall be subject to the same regulations and penalties. Inhabitants to meet, &c.

III. *And be it enacted,* That the vestry and churchwardens elected by the inhabitants of the said parish on Easter Monday, in the year one thousand seven hundred and ninety-two, shall have, and they are hereby declared to be vested with, all the power and authority of select vestries under and in virtue of the laws of this state, and shall be subject to the same regulations and penalties as if they had been elected agreeably to the act for the establishment of select vestries. Vestry, &c. vested with power, &c.

IV. *And be it enacted,* That the said vestry for the time being shall have full power and authority to sell and convey, in fee-simple, the glebe-lands belonging to said May sell the glebe-lands, &c.
