Preamble. HEREAS those who dedicate their time, abilities and labour, to the public, ought to receive a reasonable and adequate compensation for their services;

Officers fala-II. Be it enacted, by the General Assembly of Maryland, That the following ries. officers of civil government for the time being, shall be entitled to receive at the rate of the following falaries, in current money, for the enfuing year, to wit: The treasurer of the western shore, six hundred pounds; the treasurer of the eastern shore, one hundred and fifty pounds; the auditor, two hundred pounds; the clerk of the council, two hundred and fifty pounds; the clerk of the fenate, thirty pounds; the clerk of the house of delegates, seventy-five pounds; the printer to the state, three hundred and seventy-five pounds; the messenger to the council, fifty pounds.
