

C H A P. XXXVI.

A Further supplement to an act, entitled, An act to streighten and amend the public roads in Harford county.

Passed December 24,

WHEREAS by an act passed at November session, seventeen hundred and ninety-three, entitled, A supplement to an act, entitled, An act to streighten and amend the public roads in Harford county, and for other purposes, three persons were appointed by the justices of the levy court in said county to lay out, mark and bound, such roads in said county as in the original act were intended to be laid out, and as should to the said justices be considered necessary: And whereas the persons so appointed proceeded, among other roads, to lay out, mark and bound, a certain road known by the name of the Conojoholah, leading over Slate ridge until it intersects the Pennsylvania line, and a certain other road laid out, marked and bounded, from Coop's-town to Hannaway's mill, and from thence through the plantation of a certain Lloyd Marsh till it intersects a road leading to Baltimore: And whereas another road was laid out by the commissioners appointed by the directions of the original act to which this is a further supplement, leading from the upper cross roads to the Whitehouse, and it being represented to this general assembly, that sundry inhabitants of said county are much aggrieved by reason of the aforesaid roads being so laid out as aforesaid; therefore,

II. Be it enacted, by the General Assembly of Maryland, That the levy court in Harford county be and they are hereby empowered and directed to appoint, by warrant under their hands, seven persons, freeholders and residents in said county, to review the above described roads, which said persons, so appointed as aforesaid, shall and they are hereby directed and required, as soon as conveniently may be thereafter, to meet, examine and review, the above described roads as laid out, marked and bounded, as aforesaid, and if, upon such review, they in their judgments shall be of opinion that the above described roads, as laid out as aforesaid, ought to be altered, then they are hereby required to lay out, survey, mark and bound, the above described roads, and make return thereof agreeably to the directions and regulations of the original act to which this is a further supplement, and the said court, if they shall approve of the same, thereupon shall direct the said roads so laid out to be cleared and amended in the same manner as is directed by the said original act.

Levy court to appoint persons, &c.

III. And be it enacted, That the said persons, appointed under and in virtue of this act, shall, before they proceed to exercise the powers hereby given, take the oath prescribed by the said original act, and shall have the same allowance as the original commissioners appointed under the original act for their actual services.

Who shall take an oath, &c.

IV. And be it enacted, That this act shall continue and be in force until the first day of October next, and until the next session of assembly thereafter.

C H A P. XXXVII.

An additional supplementary act to the act, entitled, An act for the marking of highways, and making the heads of rivers, creeks, branches and swamps, passable for horse and foot. 1704.

Passed December 24.

WHEREAS the act, entitled, An act for the marking of highways, and making the heads of rivers, creeks, branches and swamps, passable for horse and foot, and the supplementary acts thereto, authorize the overseers of the highways to cut down trees of a certain description for the making of and repairing bridges over the heads of rivers, creeks, branches, swamps, or other low and miry places, and no provision being made by any of the said acts for making the proprietors of the same any compensation therefor; therefore,
