 "case may be,) through the land of C. D. in pursuance of this act," and shall
 return the estimation of damages by them so assessed to the clerk of Baltimore
 county, under their hands and seals; and the estimation of damages by them so
 assessed, or a majority of them, shall be final and conclusive.

C H A P.
LVIII.

IV. And be it enacted, That all damages, costs and expences, attending the
 laying out, extending and confirming, the said road, shall be paid by the petiti-
 oners for the same.

V. And be it enacted, That the commissioners aforesaid shall not have power
 to open the said road through the land of any proprietor without his or her con-
 sent, until the expiration of twelve months next after the making of the award
 aforesaid, or in case of the intervention of a jury until the expiration of twelve
 months after the return as aforesaid of their inquisition, and moreover until the
 damages ascertained as aforesaid shall have been paid, or tender thereof made.

An ACT to incorporate an insurance company in Baltimore-town. Passed De-
 cember 24.
 Preamble.

 the insurance of ships and merchandise at sea, and have prayed to be
