That for every hogshead of tobacco inspected after the Five shillings passage of this act, there shall be paid to the inspector or inspectors delivering the and fix-pence to be paid, fame the fum of five shillings and fix-pence current money, in order to defray &c. the inspectors salaries and the warehouse rent; and for every hogshead of tobacco inspected as aforesaid, the justices of the levy courts, or any three or more of them, shall allow the proprietor of the warehouse a sum not exceeding three shillings current money, nor less than one shilling and fix-pence; provided always, that no more than four shillings per hogshead shall be paid for each hogshead of tobacco inspected in Prince-George's county.

That an act to regulate the inspection of tobacco, Parts of sevepassed at November session, seventeen hundred and eighty-nine, and the several nudd. fupplementary acts thereto, passed November session, seventeen hundred and ninety, are hereby continued until the twentieth day of October next, and until the end of the next session of assembly which shall happen thereafter, except such parts thereof as are inconfistent or contrary to the provisions of this act, also so much of the faid acts as prevent persons from carrying out of the counties where it was made, either by land or water, any tobacco, until it has been inspected at fome public warehouse in the said county, unless he shall choose to carry it to some one public warehouse at the next adjacent county, and except also such part of the fourteenth section of the act to regulate the inspection of tobacco as directs the infpector to take an oath, or affirmation, that he will not receive any tobacco which is mixed with trash tobacco, which said excepted parts are hereby repealed.

And be it enacted, That so much of an additional supplementary act to Part of an act an act, entitled, An act to regulate the inspection of tobacco, passed in the year one thousand seven hundred and ninety-one, as relates to the adjournment of the levy court of Montgomery county, is hereby repealed; and the inspectors of tobacco in Montgomery county shall hereafter settle their accounts with the levy court of faid county on the fourth Monday in December annually, for which purpose the said court shall adjourn to the said fourth Monday in December in each year.

C H A P. LXXII.

An ACT authorifing a lottery in Havre-de-Grace for the purpose Passed Detherein mentioned.

THEREAS it is represented to this general affembly, that the building Preamble. and erecting two public wharfs in the town of Havre-de-Grace will tend very much to the accommodation of boats coming down the Susquehanna; therefore,

II. Be it enacted, by the General Assembly of Maryland, That it shall and Commissionmay be lawful for the commissioners of Havre-de-Grace, or a majority of them, ers may proto propose any scheme or schemes of a lottery for raising the sum of five thousand scheme, &c. dollars, and to fell and dispose of the tickets therein; provided the said commissioners, or a majority of them, shall, before the sale or disposal of any ticket or tickets in faid lottery, give bond to the state of Maryland, in the penalty of twelve thousand dollars, conditioned, that they will well and truly apply the monies arising therefrom, within two months after the drawing thereof, to the payment of the prizes drawn by the fortunate adventurers in said lottery, and the necessary expences incurred in the management thereof, and the residue to the building and erecting the faid public wharfs, the building and erecting of which the faid commissioners, and their successors, are hereby authorised to direct and superintend.

III. And be it enacted, That the said bond shall be lodged in the clerk's of- Bond to be fice of Harford county, to be there recorded, and upon such bond, or an office office, &c.
