INTRODUCTION OF BILLS

House Bill No. 1—By The Speaker:

A Bill entitled "An Act to add new Sections 11, 12, 13, 14 and 15 to Article 49B of the Annotated Code of Maryland (1957 Edition), title 'Interracial Commission,' to follow immediately after Section 10 thereof, and to be under the new subtitle 'Public Accommodations,' to prohibit discrimination on the basis of race, creed, color or national origin in certain places of public accommodations, with exceptions, which provide sleeping accommodations or serve meals for a consideration, placing the administration and enforcement of this subtitle initially
