# LAID OVER BILL WITH AMENDMENTS

## Amendments to House Bill No. 1

By the Committee:

Amendment No. 1—In line 1 of the title and in line 2 of Section 1 on page 1 of the first reading file bill, strike out the following in each instance: "and 15" and insert in lieu thereof the following in each instance: ", 15 and 16".
