(c) The salary of each of the judges of the several circuit courts of the first seven judicial circuits shall be [~~fifteen thousand dollars (\$15,000.00)~~] *twenty thousand dollars (\$20,000.00)* per annum.

Sec. 2. *And be it further enacted,* That nothing in this Act shall be construed to modify or affect in any manner the provisions of Section 2 of Chapter 889 of the Acts of 1945 or the provisions of Section 4 of Chapter 81 of the Acts of 1949.

Sec. 3. *And be it further enacted,* That this Act shall take effect July 1, 1962.

AN ACT TO REPEAL SUBSECTIONS (B) AND (C) OF SECTION 47 OF ARTICLE 26 OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION), TITLE "COURTS", SUB-TITLE "SALARIES OF JUDGES", AND TO ENACT IN LIEU THEREOF NEW SUBSECTIONS (B), (C), (C-1), (C-2), AND (C-3) TO STAND IN THE PLACE OF THE SECTIONS SO REPEALED, REVISING THE LAWS CONCERNING THE SALARIES OF THE JUDGES OF THE SEVERAL COURTS OF THE EIGHT JUDICIAL CIRCUITS OF THIS STATE, PROVIDING FOR THE EXTENT OF THE STATE'S PARTICIPATION IN THE PAYMENT OF SUCH SALARIES, PROVIDING A MAXIMUM FOR THE PAYMENT OF SUPPLEMENTARY SALARIES BY THE SEVERAL POLITICAL SUBDIVISIONS, AND RELATING GENERALLY TO THE SALARIES OF THE JUDGES OF THE SEVERAL COURTS OF THE EIGHT JUDICIAL CIRCUITS OF MARYLAND.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, THAT SUBSECTIONS (B) AND (C) OF SECTION 47 OF ARTICLE 26 OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION), TITLE "COURTS", SUB-TITLE "SALARIES OF JUDGES", BE AND THEY ARE HEREBY REPEALED; THAT NEW SUBSECTIONS (B), (C), (C-1), (C-2), AND (C-3) BE AND THEY ARE HEREBY ENACTED IN LIEU THEREOF, TO STAND IN THE PLACE OF THE SECTIONS SO REPEALED, AND ALL TO READ AS FOLLOWS:

(B) THE SALARY PAID TO, OR ALLOWED, FOR EACH OF THE JUDGES OF THE SEVERAL COURTS OF THE EIGHT JUDICIAL CIRCUITS IS TWENTY THOUSAND DOLLARS (\$20,000.) PER ANNUM.

(C) THE SALARY SPECIFIED IN SUBSECTION (B) SHALL BE PAID IN FULL AMOUNT TO ANY JUDGE OF SUCH A COURT WHO RECEIVES NO SUPPLEMENTATION OR ADDITIONAL PAYMENTS AS SALARY (HEREAFTER IN THIS SECTION REFERRED TO AS "SUPPLEMENTATION") FROM A POLITICAL SUBDIVISION.

(C-1) THE SALARY SPECIFIED IN SUBSECTION (B) SHALL BE PAID IN REDUCED AMOUNT TO ANY JUDGE OF SUCH A
