are hereby authorised and directed to pay, out of any unappropriated or surplus C H A P. money which shall be in their respective treasuries, unto each juryman of the general court on the western and eastern shores, or his assigns, upon such juryman, or his assigns, producing a certificate from either of the clerks of faid court, fuch sum as may appear to be due upon the face of such certificate, and the faid payments shall be made at the city of Annapolis, or the town of Easton.

III. And he it enacted, That the clerks of the faid courts shall and they are Clerks to hereby directed to make out such certificates, with the several sums so due extissicates, &c. pressed in words at length; and the said clerks shall return to the general assembly of Maryland, on or before the twentieth day of November in each year, a true and accurate account of the amount of all certificates so as aforesaid by them isfued.

IV. and be it enacted, That there shall be allowed to each grand and petit Allowance to juryman attending the feveral county courts, and each petit juryman attending jurymen, &c. the orphans courts, in this state, the sum of one dollar and fifty cents for each and every day such grand and petit juryman shall attend for the discharge of his duty as fuch, to be allowed, affeffed and levied, in the feveral and respective counties of this state, in the same manner as the allowances to jurymen have heretofore been affessed and levied.

V. And be it enacted, That there shall be allowed to each witness attending To witnesses the general court on the western and eastern shores of this state the sum of one court, &c. dollar and fifty cents for each and every day fuch witness shall attend for the difcharge of his duty, besides itinerant charges.

VI. and be it enacted, That there shall be allowed to each witness attending And to the the county or orphans courts of this state the sum of one dollar for each and &c. every day such witness shall attend for the discharge of his duty, besides itinerant charges to be allowed to witnesses coming from other counties.

VII. and be it enacted, That all laws heretofore passed, whereby any other Former laws allowance is directed to be made to any juryman or witness for his atten-repealed. dance as aforesaid, be and the same are hereby repealed, so far as the same shall be repugnant to, or in any manner inconsistent with, the provisions contained in this act.

VIII. And he it enace, That there shall be allowed to each grand and petit Allowance to juryman attending Allegany county court, and each petit juryman attending jurors in Allegany. the orphans court in Allegany county, the sum of one dollar for each and every &c. day fuch grand and petit juryman shall attend for the discharge of his duty as fuch, to be allowed, affeffed and levied, in faid county, in the same manner as allowances to jurymen have heretofore been affeffed and levied, any thing in this act to the contrary notwithstanding.

IX. And be it enacted, That there shall be allowed to each grand and petit And in Balti: juryman attending Baltimore county court, and each petit juryman attending the more county, orphans court in Baltimore county, the fum of one dollar and thirty-three cents for each and every day such grand and petit juryman shall attend for the discharge of his duty as such, to be allowed, affested and levied, in said county, in the fame manner as allowances to jurymen have heretofore been affeffed and levied, any thing in this act to the contrary notwithstanding.

X. This act to continue and be in force till the twentieth day of October, Duration. one thousand eight hundred, and until the end of the next session of assembly that shall happen thereafter.
