faid commissioners, and their successors, for the use and in trust for the benefit C H A P. and advantage of the inhabitants of the faid town; and the clerk of the faid market shall have full power, under the direction of the said commissioners, to rent and hire out the stalls and shambles of the said market-house upon the best terms, and to keep a fair and just account, as well of the persons renting as of the profits arising from such rents, and to render duplicates of such accounts to the faid commissioners annually, on the first Monday of March, or oftener if he shall be required; and the said rents and profits shall be paid to the order of the said commiffioners, and be applied to the uses directed by this act, and in default of payment, the same shall be recovered, in the name of the said commissioners. from any tenant or person resusing or delaying to pay the same, by the warrant of a justice of the peace, as in the case of small debts before a magistrate; and the clerk of the faid market shall be allowed a reasonable compensation for his fervices, not exceeding the fum of twenty dollars per annum, to be afcertained by the faid commissioners, and to be raised by voluntary contribution from the inhabitants of faid town.

XIII. And be it enacted, That the commissioners of the said town shall, on A meeting to the first Monday of March, one thousand seven hundred and ninety-nine, and becalled, &c. annually on the first Monday in March thereafter, by public notice of at least ten days, call a meeting of the inhabitants of faid town who are entitled to vote, to choose commissioners for the ensuing year, at which election any justice of the peace may prefide; and the faid inhabitants shall then choose, viva voce, five discreet reputable persons, inhabitants of said town, or of Sand-town, in Queen-Anne's county, to act as commissioners for one year from and after the first day of April next ensuing; and it shall be lawful for all male white persons, rendents of faid town, and having a family therein, to vote at faid elections for commissioners, and the five persons having the greatest number of votes at said election shall be commissioners for one year, to execute the duties of this act; and the commissioners shall, by election among themselves, fill all vacancies which may happen in their own body within the year.

XIV. and be it enamed. That it shall not be lawful for any person or persons Swine not to suffer swine to go at large within the circle of one half mile from Gilpin's go at large, acc. brick mill; and if any swine shall be found going at large within the limits aforesaid, it shall be lawful for any person to seize and impound the same, giving notice thereof at the market-house aforesaid for five days successively, and if no person shall claim such swine within the five days aforesaid, and if claimed, and the owner will not pay within the faid five days the sum of three shillings and nine-pence per head for each and every day such swine shall be impounded, it shall and may be lawful for the person making such seizure to sell such swine, and after deducting the fum of three shillings and nine-pence per head for each and every day the faid swine has been impounded, he shall pay the balance, if any, to the commissioners of said town, to be applied as is hereafter directed, if not demanded by the owner or owners of fuch fwine in three months after the time of fale.

XV. And be it enacted, That the fines, penalties and forfeitures, incurred how fines, under this act, shall be recovered before a justice of the peace, upon the competent, on oath or affirmation, of one competent and credible witness, as other accordingly finall debts are recovered, and the said penalties and forfeitures shall be paid to the commissioner first named in this act, and hereafter to his successor, having the greatest number of votes at any election for commissioners which shall hereafter take place, to be applied, under the direction of a majority of faid commissioners, to the repair and support of the said market-house, or otherwise, as they in their discretion may think proper, for the improvement and regulation of the said town, and for the improvement of Sand-town, in Queen-Anne's county.
