

COUNTY", SUB-TITLE "WASHINGTON SUBURBAN SANITARY DISTRICT", AND TO ADD A NEW SECTION TO THE MONTGOMERY COUNTY CODE (1955 EDITION), BEING ARTICLE 16 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, TITLE "MONTGOMERY COUNTY", SAID NEW SECTIONS TO FOLLOW, RESPECTIVELY, AFTER SECTION 1575A OF THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY (1953 EDITION) AND SECTION 74-40.1 OF THE MONTGOMERY COUNTY CODE (1955 EDITION), SAID NEW SECTIONS ALSO FOLLOWING, AS A SINGLE NEW SECTION, SECTION 1575B (74-40.2) CONTAINED IN THE 1959 PAMPHLET EDITION (EVERSTINE) OF THE LAWS OF THE WASHINGTON SUBURBAN SANITARY DISTRICT, AUTHORIZING THE WASHINGTON SUBURBAN SANITARY COMMISSION TO REGULATE SEWER CLEANING AND SIMILAR ACTIVITIES IN THE SANITARY DISTRICT AND ON PREMISES CONNECTED TO THE COMMISSION'S SANITARY SEWERAGE SYSTEM; PROVIDING FOR THE ISSUANCE OF LICENSES AND RENEWALS THEREOF BY THE COMMISSION FOR SEWER CLEANERS AND MAKING PROVISION FOR LICENSING OF PERSONS PRESENTLY ENGAGED IN THE SEWER CLEANING BUSINESS; AND PRESCRIBING PENALTIES FOR VIOLATIONS OF THE PROVISIONS HEREOF.

*Section 1. Be it enacted by the General Assembly of Maryland, That Section 1575C be, and it is hereby added to the Code of Public Local Laws of Prince George's County (1953 Edition), being Article 17 of the Code of Public Local Laws of Maryland, title "Prince George's County", sub-title "Washington Suburban Sanitary District", to follow immediately after Section 1575B thereof, and that Section 74-40.3 be and it is hereby added to the Montgomery County Code (1955 Edition), being Article 16 of the Code of Public Local Laws of Maryland, title "Montgomery County", sub-title "Washington Suburban Sanitary District", to follow immediately after Section 74-40.2, and to read as follows:*

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, THAT SECTION 1575B BE, AND IT IS HEREBY ADDED TO THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY (1953 EDITION), BEING ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, TITLE "PRINCE GEORGE'S COUNTY", SUB-TITLE "WASHINGTON SUBURBAN SANITARY DISTRICT", TO FOLLOW IMMEDIATELY AFTER SECTION 1575A THEREOF, AND THAT SECTION 74-40.2 BE AND IT IS HEREBY ADDED TO THE MONTGOMERY COUNTY CODE (1955 EDITION), BEING ARTICLE 16 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, TITLE "MONTGOMERY COUNTY", SUB-TITLE "WASHINGTON SUBURBAN SANITARY DISTRICT", TO FOLLOW IMMEDIATELY AFTER SECTION 74-40.1, SAID NEW SECTIONS TO FOLLOW, AS A SINGLE NEW SECTION, SECTION 1575B (74-40.2) CONTAINED IN THE 1959 PAMPHLET EDITION (EVERSTINE) OF THE LAWS OF THE WASHINGTON SUBURBAN SANITARY DISTRICT, AND TO READ AS FOLLOWS:
