AN AREA OR PORTION OF SAID LICENSED PREMISES, WHERE-IN THERE ARE MAINTAINED "OFF SALE" SHELVES OR COUNTERS NOT CONTAINED WITHIN AND AN INTEGRAL PART OF THE MAIN BAR AND IN THE MAIN DINING FACILI-TIES WHERE THE MAJORITY OF THE MEALS ARE SERVED AND CONSUMED IN THE LICENSED PREMISES (WHETHER ENCLOSED OR OPEN, PARTITIONED OR OTHERWISE PART-LY SEPARATED FROM THE MAIN BAR OR THE USUAL
