(2) Class BTM, on sale generally, taverns, with music, but without dancing or other similar entertainment;] the annual license fee shall be [~~one hundred dollars (\$100.00)~~] *two hundred and fifty dollars (\$250.00)*.

(N) THIS SECTION SHALL NOT APPLY TO BALTIMORE CITY, NOR TO ANNE ARUNDEL, BALTIMORE, CAROLINE, DORCHESTER, FREDERICK, HARFORD, SOMERSET, AND TALBOT COUNTIES, IN ALL OF WHICH JURISDICTIONS SUCH LICENSES SHALL NOT BE ISSUED.
