 Worths Holly, being One Thousand Acres and part of a tract of
~~of the said Buck Hill~~, Buck Hill being fifty Acres of the
 Benjamins Lott, Beginning at the westermost bounds of the
 Intersect the Eastermost bounds of a parcoll of Land Pickle-
 Intersect a North Line of the said Buck Hill then running Par-
 mentioned bounds, The said Lands situate lying and being in
 Holly Beginning at a Bounded Red Oak, standing at the West
 down the said Creek South west Sixty Eight Perches, to another

 William Sigley his Heires or his Assignes all any time during
 or Cause to be made Done Executed & suffered all such further
 the Grantes, As he or their Council Learned in the Law shall see
 the parties abovesaid have Interchangeably set herunto our home
