

*Election District (No. 14), and Prince George's County, to its point of intersection with the westerly right-of-way line of the Baltimore-Washington Parkway, being the easternmost boundary of the Maryland-Washington Metropolitan District; thence in a southerly direction with and along the said easternmost boundary of the Maryland-Washington Metropolitan District to its intersection with the northern boundary line of the Kent Election District (No. 13); thence with and along the said boundary line of the Kent Election District (No. 13) in an easterly and southerly direction to its point of intersection with the John Hanson Highway, being the point of beginning.*

SEC. 2. *And be it further enacted, That this Act is hereby declared to be an emergency measure and necessary for the immediate preservation of the public health and safety, and being passed by a ye and nay vote supported by three-fifths of all the members elected to each of the two houses of the General Assembly, the same shall take effect from the date of its passage.*

CHAPTER 739

(House Bill 783)

AN ACT to repeal and re-enact, with amendments, Sections 121 and 122 of the Code of Public Local Laws of Charles County (1962 Supplement, being Article 9 of the Code of Public Local Laws of Maryland), title "Charles County," subtitle "Fire Companies," to increase AND CHANGE THE METHOD OF COMPUTING annual appropriations by Charles County to certain fire companies and rescue squads in the county, and adding Waldorf AND BEL ALTON Volunteer Fire ~~Department~~ DEPARTMENTS to those receiving appropriations, , ELIMINATING THE ANNUAL APPROPRIATION TO THE CHARLES COUNTY CENTRAL FIRE WATCH.

SECTION 1. *Be it enacted by the General Assembly of Maryland, That Sections 121 and 122 of the Code of Public Local Laws of Charles County (1962 Supplement, being Article 9 of the Code of Public Local Laws of Maryland), title "Charles County," subtitle "Fire Companies," be and they are hereby repealed and re-enacted, with amendments, to read as follows:*
