

IONS. THE COUNTY COMMISSIONERS ARE HEREBY DIRECTED TO LEVY A SPECIAL TAX IF NECESSARY, IN EACH ELECTION DISTRICT SUFFICIENT TO PAY THE SALARIES OF THE ENGINEMEN AND RELIEF ENGINEMEN OF THE SEVERAL VOLUNTEER FIRE COMPANIES AND TO PAY THE salary of each engineman and relief engineman.

SEC. 2. *And be it further enacted*, That this Act shall take effect June 1, 1963.

CHAPTER 795
(House Bill 651)

AN ACT to add new Section 28(i) to Article 2B of the Annotated Code of Maryland (1957 Edition and 1962 Supplement), title "Alcoholic Beverages," subtitle "Local Licenses and License Provisions," to follow immediately after Section 28 (h) thereof, relating to the issuance of licenses for the sale of alcoholic beverages in Anne Arundel County, except for the Sixth Election District thereof.

SECTION 1. *Be it enacted by the General Assembly of Maryland*, That new Section 28(i) be and it is hereby added to Article 2B of the Annotated Code of Maryland (1957 Edition and 1962 Supplement), title "Alcoholic Beverages," subtitle "Local Licenses and License Provisions," to follow immediately after Section 28(h) thereof, and to read as follows :

28(i).

(1) *The number of premises for which licenses (including all classes or types of alcoholic beverage licenses which may be issued in said ~~Election District~~ ANY ELECTION PRECINCT for the sale of alcoholic beverages at retail may be issued in or transferred to a ~~district~~ PRECINCT of Anne Arundel County is limited to one for each 1,000, or major fraction thereof, registered voters of the ~~district~~ PRECINCT in which the premises are located.*

(2) *No additional licenses (including all types and classes of alcoholic beverage licenses for the sale of alcoholic beverages at retail) shall be issued in any ~~District~~ PRECINCT of Anne Arundel County (except the Sixth District) where the number of all licensed premises for the sale of alcoholic beverages at retail is more than one for each 1,000 or major fraction thereof, of registered voters of said ~~District~~ PRECINCT except by renewal as provided in Section 68 of this Article, as amended, or by transfer within a ~~district~~ PRECINCT as provided by Sections 74 and 78 of this Article as amended, which ever shall be applicable, or by exchange of the license issued for another license of a different type or class, which exchange of license shall be made in accordance with the "Procedure for issue of Licenses" as set forth in Sections 59 through 67 of this Article, as amended.*

(3) *Nothing in this subsection shall require the cancellation of*
