I, LLOYD L. SIMPKINS, SECRETARY OF STATE OF THE STATE OF MARYLAND, pursuant to the direction contained in Section 172 of Article 33 of the Annotated Code of Maryland, (1957 Edition,) DO HEREBY CERTIFY, that at the General Election held in the State of Maryland on November 6, 1962, an Act known as Chapter 616 of the Acts of 1961, was submitted to the voters of the State of Maryland pursuant to the provisions of Article XVI of the Constitution of the State of Maryland, said Act being as follows:
