

NOT MORE THAN FIFTY DOLLARS FOR EACH SUBSEQUENT OFFENSE.

(G) THE OWNER OF ANY DOG SEIZED AS PROVIDED IN SUBSECTION (D) HEREOF MUST REDEEM IT WITHIN NINETY-SIX HOURS FROM THE TIME OF ITS APPREHENSION, IN ACCORDANCE WITH THE PROVISIONS OF SUBSECTION (E) HEREOF OR IT WILL BE DISPOSED OF IN ACCORDANCE WITH SECTION 3-60 HEREOF.

EVERY PERSON OWNING OR HARBORING A DOG WITHIN THE COUNTY SHALL APPLY, EITHER ORALLY OR IN WRITING TO THE COUNTY TREASURER, OR SUCH AGENTS AS ARE DULY AUTHORIZED AND ADVERTISED BY THE BOARD OF COUNTY COMMISSIONERS TO SELL AND TO ENFORCE THIS LICENSING ACT, FOR A LICENSE CERTIFICATE AND TAG FOR EACH DOG OWNED OR HARBORED BY HIM, EXCEPTING DOGS KEPT UNDER A KENNEL LICENSE AS PROVIDED FOR IN SECTION 3-42 OF THIS CODE, AND SUCH APPLICATION SHALL STATE THE NAME, SEX, BREED, AGE, COLOR AND MARKINGS OF EACH SUCH DOG AND BE ACCOMPANIED BY A FEE OF TWO DOLLARS FOR EACH MALE OR SUCCESSFULLY SPAYED FEMALE, AND A FEE OF FOUR DOLLARS FOR EACH UNSPAYED FEMALE, WHOSE LICENSE TAG SHALL BE STAMPED WITH THE LETTER "F" BEFORE THE TAG NUMBER.

ON OR BEFORE JANUARY FIRST AND NOT LATER THAN THE LAST DAY OF FEBRUARY IN EACH YEAR, THE OWNER OR HARBORER OF ANY DOG FOUR MONTHS OLD OR OLDER SHALL PAY THE LICENSE TAX AS ABOVE PRESCRIBED.

INDIVIDUAL LICENSE CERTIFICATES AND THEIR ACCOMPANYING TAGS ATTACH TO THE DOG FOR WHICH ISSUED, AND UNLESS SURRENDERED TO THE COUNTY TREASURER, PASS WITH THE DOG UPON ITS CHANGE OF OWNERSHIP, BUT IN ORDER TO CONSTITUTE AN OFFICIAL RECORD OF SUCH NEW OWNERSHIP, THE ORIGINAL CERTIFICATE AND ITS ACCOMPANYING TAG MUST BE SURRENDERED TO THE COUNTY TREASURER FOR ISSUANCE OF A DUPLICATE LICENSE AND TAG AT A COST OF [TWENTY-FIVE] FIFTY CENTS; THE SURRENDERED CERTIFICATE AND TAG BEING ATTACHED TO THE STUB OF THE NEW CERTIFICATE AND THE NEW CERTIFICATE AND ITS STUB BEING MARKED "CHANGE OF OWNERSHIP."

IN CASE OF LOSS OF A LICENSE TAG, THE OWNER THEREOF MAY PROCURE A DUPLICATE LICENSE FOR USE DURING THE BALANCE OF THE YEAR BY SURRENDER OF THE OLD CERTIFICATE AND THE PAYMENT OF [TWENTY-FIVE] FIFTY CENTS.
