or the resolution of the Commissioners of Finance authorizing the issuance of ANY OF said bonds, or any portion thereof, as the ease may be, shall set forth in detail the dates when any of the bonds are to mature and the amount to mature upon such dates.

- SEC. 3. And be it further enacted, That the actual cash proceeds derived from the sale of the bonds authorized to be issued under the provisions of this Act, not exceeding the par value thereof, shall be used exclusively for the following purposes, to wit:
- (a) So much thereof as may be necessary, in addition to the premiums realized from the sale, if any, for the cost of issuance, including the expense of engraving, printing, advertising, attorney's fees, and all other incidental expenses connected therewith; and
- (b) (A) One Million Five Hundred Thousand Dollars (\$1,500,-000.00) of such proceeds (LESS SO MUCH THEREOF AS MAY BE NECESSARY, IN ADDITION TO THE PREMIUMS REAL-IZED FROM THE SALE, IF ANY, FOR THE COST OF ISSUANCE, INCLUDING THE EXPENSE OF ENGRAVING, PRINT-ING, ADVERTISING, ATTORNEYS' FEES, AND ALL OTHER INCIDENTAL EXPENSES CONNECTED THEREWITH) shall be used for the acquisition, by purchase or condemnation or any other legal means, of land or property in the City of Baltimore, and establishing thereon or therein, or on or in land or property now or hereafter owned by the Mayor and City Council of Baltimore, new playgrounds, playfields, recreational centers or recreational buildings, and for the redesign, development and improvement of park, school and other properties now or hereafter owned by the Mayor and City Council of Baltimore for recreational purposes, and for the acquisition and installation of equipment for any new or redesigned, redeveloped or improved playground, playfield, recreational center or building, and for doing any and all things necessary, proper or expedient in connection with or pertaining to any or all of the matters or things hereinbefore mentioned; and
- (e) (B) Two Million Three Hundred Thousand Dollars (\$2,300,000.00) of such proceeds (LESS SO MUCH THEREOF AS MAY BE NECESSARY, IN ADDITION TO THE PREMIUMS REALIZED FROM THE SALE, IF ANY, FOR THE COST OF ISSUANCE, INCLUDING THE EXPENSE OF ENGRAVING, PRINTING, ADVERTISING, ATTORNEYS' FEES, AND ALL OTHER INCIDENTAL EXPENSES CONNECTED THEREWITH) shall be used for the acquisition, construction, reconstruction, installation, erection, protection, extension, enlargement, renovation or modernization of, and additions to, public park or recreational buildings, structures or facilities, including, but not limited to, the zoo located in Druid Hill Park and the Baltimore Memorial Stadium, fronting on Thirty-third Street, both of which are located in Baltimore City, and for the acquisition and installation of equipment for any and all new facilities authorized to be constructed or erected under the provisions hereof, and for doing any and all things necessary, proper or expedient in connection with or pertaining to any or all of the matters or things hereinbefore mentioned; and
- (d) The remainder of such proceeds, after providing for the payment of the items mentioned in sub-paragraph (a) hereof and providing for the purposes mentioned in sub-paragraphs (b) and (c)
