CROPS INTO STORAGE FACILITIES ON THE FARM, AND (2) ALSO INCLUDING BUT NOT LIMITED TO POWER SPRAYING EQUIPMENT, IRRIGATION EQUIPMENT AND PORTABLE GRAIN AND HAY DRYERS, AND (3) ALSO BUT NOT LIMITED TO MILKING MACHINES:

- (1) ON EACH SALE WHERE THE PRICE IS FROM FIFTY-ONE CENTS (51ϕ) TO ONE DOLLAR (\$1.00), TWO CENTS (2ϕ) ;
- (2) ON EACH FIFTY CENTS (50ϕ) OF PRICE OR FRACTION THEREOF IN EXCESS OF ONE DOLLAR (\$1.00), ONE CENT (1ϕ) .

S=3. 5. And be it further enacted, That a new Section 81A be and it is hereby added to Article 66-1/2 of said Code (1957 Edition and 1963 Supplement), title "Motor Vehicles", sub-title "Administration—Registration—Titling", to follow immediately after Section 81 thereof, and to read as follows:

Article 66 1/2

81A.

- (a) The Board of County Commissioners or County Council of every county in this State, and the Mayor and City Council of Baltimore, all hereafter in this section referred to as counties, may impose and provide for a supplementary schedule of motor vehicle registration fees, as in this section provided.
- (b) Such a supplementary schedule, if imposed, shall be upon the classes of motor vehicles and other vehicles listed in Section 81 of this Article.
- (c) For those classes of motor vehicles and other vehicles listed in Section 81 of this subtitle and having therein an annual State registration fee of fourteen dollars (\$14.00) or less, the supplementary fee is three dollars (\$3.00) annually; for those classes of motor vehicles and other vehicles having an annual State registration fee of more than fourteen dollars (\$14.00) and not more than twenty nine dollars (\$29.00), the supplementary fee is five dollars (\$5.00) annually; for those classes of motor vehicles or other vehicles having an annual State registration fee of more than twenty-nine dollars (\$29.00) and not more than forty nine dollars (\$49.00), the supplementary fee is ten dollars (\$10.00) annually; for those classes of motor vehicles and other vehicles having an annual State registration fee of more than forty-nine dollars (\$49.00) and not more than ninety-nine dollars (\$99.00), the supplementary fee is fifteen dollars (\$15.00) annually; for those classes of motor vehicles and other vehicles having an annual State registration fee of more than ninetynine dollars (\$99.00) and not more than one hundred and ninety-nine dollars (\$199.00), the supplementary fee is twenty-five dollars (\$25.00) annually; and for those classes of motor vehicles and other vehicles having an annual State registration fee of more than one hundred ninety-nine dollars (\$199.00), the supplementary fee is thirty five dollars (\$35.00) annually.
- (d) A supplementary schedule when imposed applies to the registration of every motor vehicle and other vehicle which is listed and
