MESSAGE FROM THE GOVERNOR

March 14, 1964.

Mr. Speaker and Members of the House of Delegates:

Four days ago I issued a proclamation asking you to convene in extraordinary session to consider some legislative measures which I felt demanded your immediate attention.

Among the issues which I thought merited your consideration were proposals to rearrange the Congressional Districts of the State to meet Federal Court requirements, to reconstitute the Legislative Districts of Baltimore City in accordance with a ruling of the Circuit Court of that City and a measure to provide for equality of public accommodations. There was also the matter of passing a bill to enable the State to continue its highway program.
