Acts of the Regular Session of 1964, which Chapter 17 enacted the said sections so repealed, revising certain provisions of the State income tax laws as to the rate of tax imposed for each year beginning after December 31, 1964, and imposing a graduated tax on the net income of every resident individual of this State and on the net income taxable in this State of every individual not a resident of this State, specifying the rates applicable on such income, and relating generally to the imposition and collection of this tax; and repealing certain inapplicable provisions of Chapter 17 of the Acts of the Regular Session of 1964, which Act enacted the said sections so repealed.

Which was read the first time and referred to the Committee on Rules.

House Bill No. 6—By Delegate Bresler:

AN ACT to repeal and reenact with amendments Sections 288(c-2) of Article 81 of the Annotated Code of Maryland (1964 Supplement), title "Revenue and Taxes," subtitle "Income Tax," amending the laws concerning the levy and imposition of a tax on the net income of every resident individual in this State and on the net income taxable in this State of every individual not a resident of this State, in order to provide for each year beginning after December 31, 1964, for the rate of the tax on the balance of net investment income subject to the tax imposed by said subtitle.

Which was read the first time and referred to the Committee on Rules.

House Bill No 7—By Delegate O'Connell:

AN ACT to repeal Sections 288 (c-2), 288 (k), 289 (f-3) and 289 (f-4) of Article 81 of the Annotated Code of Maryland (1964 Supplement), title "Revenue and Taxes," subtitle "Income Tax," and to repeal Sections 2 and 3 of Chapter 17 of the Acts of the Regular Session of 1964, repealing the additional State income tax imposed by Chapter 17 of the Acts of the Regular Session of 1964, and also repealing certain sections of that Act which concern unappropriated surpluses and the expenditure of the additional tax on income, and relating generally to the State income tax in this State and the expenditure of the proceeds thereof; and making an appropriation from any funds in the General Surplus Fund Account of the Treasury of the State for the fiscal year ending June 30, 1965, as an emergency appropriation to the State Department of Education for Aid to Education to supplement other appropriations thereto and in lieu of a certain appropriation in the same amount in Chapter 68 of the Acts of the General Assembly for the regular session of 1964, and further providing for the distribution and disbursement of this appropriation.

Which was read the first time and referred to the Committee on Rules.

House Bill No. 8—By the Baltimore County Delegation:

AN ACT to provide for the retirement of George M. Berry, one of the Associate Judges of the Third Judicial Circuit of Maryland, he having become unable to discharge his duties with efficiency by reason of continued sickness.

Which was read the first time and referred to the Committee on Rules.
