

House Bill No. 9—By Delegate Mandel:

AN ACT to repeal and re-enact, with amendments, subsection 33½ (b) of Section 6 of the Charter and Public Local Laws of Baltimore City (1949 Edition), being Article 4 of the Code of Public Local Laws of Maryland, title "Baltimore City," subtitle "General Powers," subheading "Taxes," as said Section was enacted by Chapter 27 of the Acts of 1951, eliminating the prohibition against the imposition of certain taxes by Baltimore City and clarifying the provisions of this section.

Which was read the first time and referred to the Committee on Rules.

House Bill No. 10—By Delegate Mandel:

AN ACT to repeal Subsection (33½) (b) of Section 6 of Article 4 of the Code of Public Local Laws of Maryland and Baltimore City Charter (1949 Edition), title "Baltimore City," subtitle "General Powers," subheading "Taxes," as said subsection was enacted by Chapter 27 of the Acts of 1951, repealing certain restrictions upon the power of the Mayor and City Council of Baltimore to have and exercise taxing powers within the limits of Baltimore City.

Which was read the first time and referred to the Committee on Rules.

House Bill No. 11—Vacant.

House Bill No. 12—By the Anne Arundel County Delegation:

AN ACT to repeal Section 40(c) of Article 10 of the Annotated Code of Maryland (1964 Supplement), title "Attorneys at Law and Attorneys in Fact," subtitle "State's Attorney," and to enact a new Section 40(c) in lieu thereof to stand in the place of the section so repealed, providing for an increase in the number of assistant State's Attorneys in Anne Arundel County and compensation therefor.

Which was read the first time and referred to the Committee on Rules.

House Bill No. 13—Vacant.

House Bill No. 14—By Delegate Mandel:

AN ACT to repeal Section 81 (g) of Article 66-½ of the Annotated Code of Maryland (1964 Supplement), title "Motor Vehicles," subtitle "Administration—Registration—Titling," to repeal the requirements for prepayment of postage for the mailing of motor vehicle registration plates by the Department of Motor Vehicles to purchasers.

Which was read the first time and referred to the Committee on Rules.

House Bill No. 15—By Delegate Stark:

AN ACT to repeal and re-enact, with amendments, Section 370 of Article 81 of the Annotated Code of Maryland (1957 Edition), title "Revenue and Taxes," subtitle "Retail Sales Tax Act," subheading "Disposition of Proceeds," to provide for the distribution of a share of the proceeds of the State sales tax to the political subdivisions of the State.

Which was read the first time and referred to the Committee on Rules.
