MESSAGE FROM THE EXECUTIVE

Address by Governor J. Millard Tawes opening of the General Assembly, Special Session, Friday, November 6, 1964 State House, Annapolis, Maryland.

*Mr. President, Mr. Speaker, Ladies and Gentlemen of the
General Assembly:*

I have convened the General Assembly in special session today to ask you to review and reconsider the action that was taken at the regular session earlier this year to finance a new program of public education and other services provided by the State Government.

It was the clear intent of this Legislature and this Administration, expressed both by word and by deed, that the income tax increase which you authorized would not actually be imposed upon the people if a rising economy continued to pour revenues into our treasury in an amount sufficient to pay for our increased needs.

It is a pleasure to me to report to you, at the opening of this special session, that the Board of Revenue Estimates has advised me that our economy has prospered—at a rate that is unprecedented, in fact—that our revenues have increased proportionately and that we are now in a position where we can safely do what we had all hoped we could do, and
