

WEDNESDAY, January 25th, 1843.

The House met. Present at the call of the roll the following members :

The Journal of yesterday was read.

On motion of Mr. Spence,

Leave was granted to Messrs. Spence, Springer and Graves, to bring in a bill entitled, an act supplemental to an act, vesting certain powers in Baltimore county court, passed at December session 1833.

Mr. Morsell presented the report of the trustees of Lower Marlboro' Academy in Calvert county ;

Read and referred to the committee on Education.

Also, the memorial of sundry citizens of Calvert county, in relation to the tobacco damaged in tobacco warehouse No. 2, last fall ;

Read and referred to the committee already raised on that subject.

Mr. Green presented the petition of sundry citizens of Dorchester county, praying the passage of a law, giving to plaintiffs the right to require further supersedeas at the time one or both supersedeas become insolvent, and failing to give new supersedeas the right of execution ;

Read and referred to the committee on Grievances and Courts of Justice.

On motion of Mr. Causin,

Leave was granted to Messrs. Causin, Tuck, Brown, Buskirk and Spence, to bring in a bill to regulate marital rights, as they regard property.

On motion of Mr. Springer,

Leave was granted to the committee on Lotteries to bring in a bill supplementary to an act to aid in the construction of an outlet lock of the Tide Water Canal, at Bell's Ferry.

On motion of Mr. Spence,

Leave was granted to Messrs. Spence, Hamilton and Yellott, to bring in a bill to tax all unmarried men over thirty-five years of age.
