

IN ANNE ARUNDEL COUNTY, AND IN THE CITY OF FREDERICK FOR COUNTY AND MUNICIPAL TAXATION, IN THE AMOUNT OF AT LEAST TWENTY-FIVE PER CENTUM (25%) OF THE TOTAL ASSESSED VALUATION AND IN THE AMOUNT OF FORTY PER CENTUM (40%) OF THE TOTAL ASSESSED VALUATION IN FREDERICK COUNTY AND EACH YEAR BEGINNING IN THE TAX YEAR 1964 THE EXEMPTION IN FREDERICK COUNTY SHALL INCREASE TEN PER CENTUM (10%) UNTIL AN EXEMPTION OF ONE HUNDRED PER CENTUM (100%) IS REACHED; SUCH A TAX EXEMPTION AS IS PROVIDED IN THIS SUB-SECTION SHALL BE MANDATORY IN WASHINGTON COUNTY IN THE AMOUNT OF AT LEAST TWENTY-FIVE PER CENTUM (25%) OF THE TOTAL ASSESSED VALUATION; AND SUCH A TAX EXEMPTION SHALL BE MANDATORY IN KENT COUNTY AS TO ALL MANUFACTURERS EMPLOYING IN EXCESS OF THIRTY (30) PERSONS, IN THE AMOUNT OF SEVENTY-FIVE PER CENT (75%) OF THE TOTAL ASSESSED VALUATION, SAID EXEMPTION TO BE EFFECTIVE FOR THE PERIOD ENDING DECEMBER 31, 1970, ONLY. THIS SUB-SECTION DOES NOT APPLY IN OR TO CARROLL COUNTY.

SEC. 2. *AND BE IT FURTHER ENACTED*, THAT THE RESOLUTIONS PASSED BY THE BOARD OF COUNTY COMMISSIONERS OF KENT COUNTY CONCERNING THE MANUFACTURERS' INVENTORY TAX AND DATED JUNE 16, 1959, NOVEMBER 14, 1961, AND MAY 14, 1963, BE AND THEY ARE HEREBY REPEALED, RESCINDED, AND ANNULLED.

SEC. 2. 3. *And be it further enacted*, That this Act shall take effect June 1, 1965.

CHAPTER 703
(Senate Bill 211)

AN ACT relating to the Washington Suburban Sanitary District; to repeal and re-enact, with amendments, Chapter 779 of the Acts of 1959, as amended by Chapter 322 of the Acts of 1963, being Section 83-96 of the Code of Public Local Laws of Prince George's County (1963 Edition, being Article 17 of the Code of Public Local Laws of Maryland), title "Prince George's County", sub-title "Washington Suburban Sanitary District", and Section 73-78 of the Montgomery County Code—1960 (being Article 16 of the Code of Public Local Laws of Maryland), title "Montgomery County", sub-title "Chapter 73. Washington Suburban Sanitary District", relating to the submission to and approval by the Maryland-National Capital Park and Planning Commission and the County Council of Montgomery County of the five-year sewer and water construction program, and extensions thereof, by the Washington Suburban Sanitary Commission and relating generally to such program in both Montgomery and Prince George's County.
