TITLE SELLS ANY USED MOTOR VEHICLE, IT SHALL ATTACH A CERTIFICATE TO A WINDOW OF THE VEHICLE. WHENEVER ANY OTHER PERSON SHALL SELL A USED MOTOR VEHICLE, HE SHALL OBTAIN A CERTIFICATE FROM SUCH DEALER OR FACILITY AUTHORIZED UNDER THIS SUB-TITLE TO ISSUE SUCH CERTIFICATE, WHICH SHALL BE ISSUED WITHOUT CHARGE AND SHALL BE ATTACHED TO A WINDOW OF THE VEHICLE. THE CERTIFICATE CERTIFIES THAT THE VEHICLE MEETS OR EXCEEDS THE MINIMUM STANDARDS FOR EQUIPMENT AND MECHANISMS PRESCRIBED UNDER THIS SUB-TITLE. UPON MAKING APPLICATION FOR TRANSFER OF TITLE FOR THE VEHICLE, THE PURCHASER SHALL REMOVE THE CERTIFICATE FROM THE VEHICLE AND PRESENT IT TO THE DEPARTMENT AT THE TIME OF MAKING APPLICATION FOR A NEW TITLE FOR THE VEHICLE TOGETHER WITH THE SUM OF TWO DOLLARS (\$2.00) TO BE USED FOR THE PURPOSE OF ENFORCING THIS SUB-TITLE.

## 411.

- (A) ON AND AFTER JANUARY 1, 1966, BEFORE THE DE-PARTMENT REGISTERS AND TITLES ANY USED MOTOR VEHICLE, IT SHALL REQUIRE THE APPLICANT TO PAY THE FEE PRESCRIBED IN SECTION 410 AND TO PRESENT TO IT A CERTIFICATE FOR THE VEHICLE ISSUED AS PRO-VIDED FOR IN THIS SUB-TITLE.
- (B) WHEN REGISTRATION AND TITLING IS APPLIED FOR IN THIS STATE FOR A MOTOR VEHICLE WHICH IS REGISTERED OR TITLED, OR BOTH, IN ANOTHER STATE, WHICH HAS IN EFFECT IN THAT STATE A SYSTEM OF MOTOR VEHICLE INSPECTION, THE VEHICLE SHALL NOT BE REGISTERED AND TITLED IN THIS STATE UNLESS IT POSSESSES A CURRENTLY VALID INSPECTION STICKER.

## 412.

THE DEPARTMENT SHALL PROVIDE AND SUPPLY WITH-OUT CHARGE TO REGISTERED DEALERS AND APPROVED FACILITIES FORMS OF CERTIFICATES SERIALLY NUM-BERED AND CONTAINING SUCH INFORMATION AS THE DEPARTMENT MAY PRESCRIBE.

## 413.

- (A) ANY EMPLOYEE OF A REGISTERED DEALER OR APPROVED FACILITY WHO ISSUES A CERTIFICATE FOR A VEHICLE WITHOUT HAVING INSPECTED ITS EQUIPMENT AND MECHANISMS, OR WHO WILFULLY ISSUES A CERTIFICATE FOR A MOTOR VEHICLE WHICH HAS EQUIPMENT AND MECHANISMS WHICH DO NOT MEET OR EXCEED THE STANDARDS THEREFOR, IS GUILTY OF A MISDEMEANOR.
- (B) ANY PERSON WHO MAKES, ISSUES OR KNOWINGLY USES ANY IMITATION OR COUNTERFEIT OF A CERTIFICATE OR WHO ATTACHES OR CAUSES OR PERMITS TO BE ATTACHED UPON ANY MOTOR VEHICLE A CERTIFICATE
