

funds necessary to pay such principal and interest in any year, said County Council shall levy upon all property subject to taxation within Montgomery County ad valorem taxes in rate and amount sufficient to make up any such deficiency. OF THE BONDS AUTHORIZED BY THE COMMISSION AS THE SEPARATE MONTGOMERY COUNTY SERIES UNDER THIS SECTION 2, A PRINCIPAL AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000) MAY BE UTILIZED BY THE COMMISSION FOR STORM DRAINAGE PROJECTS IN MONTGOMERY COUNTY WITH RESPECT TO WHICH THE OWNER OR DEVELOPER OF A SUBDIVISION OR TRACT OF LAND PARTICIPATES FINANCIALLY PURSUANT TO SECTION 73-72 OF THE MONTGOMERY COUNTY CODE (BEING 83-90 OF THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY). THE REMAINING FUNDS OBTAINED FROM THE MONTGOMERY COUNTY SERIES OF BONDS AUTHORIZED BY THIS SECTION 2, AND ANY PORTION OF THE AFOREMENTIONED FIVE HUNDRED THOUSAND DOLLARS (\$500,000) WHICH IS NOT USED FOR CONTRIBUTION PROJECTS, SHALL BE EXPENDED BY RESOLUTION OF THE COMMISSION FOR STORM DRAINAGE PROJECTS WHICH ARE APPROVED, IN THE FOLLOWING FASHION, BY THE MEMBERS OF THE GENERAL ASSEMBLY REPRESENTING MONTGOMERY COUNTY. THE COMMISSION SHALL SUBMIT TO THE MEMBERS OF THE GENERAL ASSEMBLY REPRESENTING MONTGOMERY COUNTY COMMENCING JULY 1, 1965, AND AT LEAST QUARTERLY THEREAFTER A LIST OF STORM DRAINAGE PROJECTS AS SET FORTH IN THE "STREAM ENCLOSURE REPORT FOR MONTGOMERY COUNTY WITHIN THE WASHINGTON SUBURBAN SANITARY DISTRICT, DATED SEPTEMBER, 1964" ON WHICH THE COMMISSION HAS HELD A HEARING AND WHICH THE COMMISSION CONTEMPLATES FOR CONSTRUCTION FROM SUCH FUNDS, EXCLUDING, TO THE AFORESAID LIMITATION, THE SECTION 73-72 PROJECTS. THE SAID LIST SHALL ENUMERATE THE PROJECTS BY LOCATION OR OTHER APPROPRIATE DESIGNATION, THE ESTIMATE OF THE COST OF CONSTRUCTION OF EACH, THE ESTIMATED DATES OF COMMENCEMENT AND COMPLETION OF CONSTRUCTION, INCLUDING ESTIMATES OF TIME FOR RIGHT OF WAY ACQUISITIONS, AND SUCH OTHER INFORMATION AS THE COMMISSION MAY DEEM ADVISABLE. IF WITHIN 25 DAYS AFTER THE COMMISSION'S DISTRIBUTION TO EACH MEMBER OF SAID LIST A MAJORITY OF THE MEMBERS OF THE GENERAL ASSEMBLY REPRESENTING MONTGOMERY COUNTY IN THE HOUSE OF DELEGATES AND THE MEMBER OF THE GENERAL ASSEMBLY REPRESENTING MONTGOMERY COUNTY IN THE SENATE, OR A MAJORITY OF THE SENATORS IF THERE ARE MORE THAN ONE, DO NOT IN WRITING DISAPPROVE ANY PROJECT ON SAID LIST AS SUBMITTED BY THE COMMISSION, THEN THE COMMISSION MAY CONSTRUCT ANY PROJECT ON SUCH LIST, AND THE COMMISSION SHALL GENERALLY FOLLOW ANY ORDER OF PRIORITY IT HAS INDICATED ON SAID LIST SUBMITTED TO THE SAID MEMBERS OF THE GENERAL ASSEMBLY UNLESS THE SAID MEMBERS OF THE GEN-
