

CHAPTER 868  
(House Bill 480)

AN ACT to repeal Section 134 (e) of the Code of Public Local Laws of Howard County (1957 Edition, being Article 14 of the Code of Public Local Laws of Maryland), title "Howard County," subtitle "Metropolitan Commission," and to enact new Section 134 (e) in lieu thereof, to stand in place of the section repealed; relating to the Metropolitan Commission in Howard County and providing that the Commission shall have jurisdiction over all privately owned public water or sewerage systems constructed anywhere in Howard County, requiring permits for installation work and subjecting such systems to the continuing authority of the Commission, and including certain exceptions thereto.

AN ACT TO ADD NEW SECTION 9A (B-1) TO THE CODE OF PUBLIC LOCAL LAWS OF HOWARD COUNTY (1957 EDITION, BEING ARTICLE 14 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND), TITLE "HOWARD COUNTY," SUBTITLE "BUILDING REGULATIONS," AND TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTIONS 134 (A) AND (B) OF THE SAID CODE, SUBTITLE "METROPOLITAN COMMISSION," AND TO REPEAL SECTION 134 (C) OF THE CODE AND SUBTITLE AND TO ENACT A NEW SECTION 134 (C) IN LIEU THEREOF, RELATING TO THE JURISDICTION OF THE METROPOLITAN COMMISSION AND OF THE PLUMBING BOARD OF HOWARD COUNTY OVER WATER, SEWER AND DRAINAGE SYSTEMS, AND OVER WATER AND SEWER MAINS AND FACILITIES IN HOWARD COUNTY, TO DISTINGUISH THE JURISDICTION OF EACH BODY, TO REQUIRE PERMITS FOR INSTALLATION OF WATER AND SEWERAGE SYSTEMS, AND RELATING GENERALLY TO WATER, SEWER AND DRAINAGE IN HOWARD COUNTY.

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That Section 134 (e) of the Code of Public Local Laws of Howard County (1957 Edition, being Article 14 of the Code of Public Local Laws of Maryland), title "Howard County," subtitle "Metropolitan Commission," be and it is hereby repealed, and that new Section 134 (e) be and it is hereby enacted in lieu thereof, to stand in the place of the section repealed, and to read as follows:

THAT NEW SECTION 9A (B-1) BE AND IT IS HEREBY ADDED TO THE CODE OF PUBLIC LOCAL LAWS OF HOWARD COUNTY (1957 EDITION, BEING ARTICLE 14 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND), TITLE "HOWARD COUNTY," SUBTITLE "BUILDING REGULATIONS"; THAT SECTIONS 134 (A) AND (B) OF THE SAID CODE, SUBTITLE "METROPOLITAN COMMISSION," BE AND THEY ARE HEREBY REPEALED AND RE-ENACTED, WITH AMENDMENTS; THAT SECTION 134 (C) OF THE SAID CODE AND SUBTITLE BE AND IT IS HEREBY REPEALED AND THAT A NEW SECTION 134 (C) BE AND IT IS HEREBY ENACTED IN LIEU THEREOF, TO STAND IN THE PLACE OF THE SECTION SO REPEALED, AND ALL TO READ AS FOLLOWS:
