AN ACT TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTIONS 18, 63 (A) AND (B), 78 (A), 79 (E), (I), AND (J) OF CHAPTER 780 OF THE ACTS OF 1959 AS AMENDED, BEING ALSO SECTIONS 59-19, 59-68 (A) AND (B), ~~59-83 (A)~~, 59-85 (E), (I), AND (J) OF THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY (1963 EDITION, BEING ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND), TITLE "PRINCE GEORGE'S COUNTY," BEING ALSO SECTIONS 59-19, 59-68 (A) AND (B), ~~59-83 (A)~~, SUBTITLE "PARK AND PLANNING COMMISSION," AND TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTION 18-1 (B) OF THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY, SUBTITLE "COUNTY COMMISSIONERS," AND TO ADD A NEW SUBSECTION 78 (E) AND NEW SECTIONS 100 THROUGH 105, INCLUSIVE TO CHAPTER 780 OF THE ACTS OF 1959, AS AMENDED, BEING ALSO NEW SUBSECTION 59-83 (E) AND NEW SECTIONS 59-102 THROUGH ~~59-107~~ 59-105, INCLUSIVE, TO BE ADDED TO THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY, THE SAID NEW SUBSECTION 78 (E) AND NEW SECTIONS 100 THROUGH 105, INCLUSIVE, TO FOLLOW IMMEDIATELY AFTER SUBSECTION 78 (D) AND SECTION 99, RESPECTIVELY, RELATING GENERALLY TO PLANNING AND ZONING IN PRINCE GEORGE'S COUNTY.

*Section 1. Be it enacted by the General Assembly of Maryland, That the following sections be, and they hereby are, added to subtitle 59 of the Code of Public Local Laws of Prince George's County (1963 Edition, being Article 17 of the Code of Public Local Laws of Maryland), as enacted by Chapter 780 of the Acts of 1959, title "Prince George's County," subtitle "Park and Planning Commission," to read as follows:*

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, THAT THE FOLLOWING NEW SECTION 59-83 (E) AND SECTIONS 59-102 THROUGH ~~59-107~~ 59-105, BE AND THEY ARE HEREBY ADDED TO THE CODE OF PUBLIC LOCAL LAWS OF PRINCE GEORGE'S COUNTY (1963 EDITION, BEING ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND), AS ENACTED BY CHAPTER 780 OF THE ACTS OF 1959, AS AMENDED, TITLE "PRINCE GEORGE'S COUNTY," SUBTITLE "PARK AND PLANNING COMMISSION," THE SAID NEW SECTION 59-83 (E) TO FOLLOW IMMEDIATELY AFTER SECTION 59-83 (D) THEREOF, AND SAID SECTIONS 59-102 THROUGH 59-107 TO FOLLOW IMMEDIATELY AFTER SECTION 59-101 THEREOF, AND THAT SECTIONS 59-19, 59-68 (A) AND (B), ~~59-83 (A)~~, 59-85 (E), (I), AND (J), BEING THE SAME AS SECTIONS 18, 63 (A) AND (B), 78 (A) AND 79 (E), (I), AND (J) OF CHAPTER 780 OF THE ACTS OF 1959 AS AMENDED, BE AND THE SAME ARE
