

Local Laws of Prince George's County (1963 Edition, being Article 17 of the Code of Public Local Laws of Maryland), title "Prince George's County," subtitle "Circuit Court" and Section 45A of Article 19 of the Code of Public Local Laws of Maryland (1930 Edition), title "St. Mary's County," subtitle "Circuit Court," be and they are hereby repealed and that new Subsections (a), (b), and (c) of Section 111 of said Calvert County Code, being also Subsections (a), (b), and (c) of Section 32 of the said Charles County Code, being also Subsections (a), (b), and (c) of Section 12-10 in the said Prince George's County Code and being also Section 45A of said Article 19 of the said Code of Public Local Laws of Maryland, be and they are hereby enacted in lieu thereof and all to read as follows:

12-10. (Article 17)

(a) *The Judges of the Seventh Judicial Circuit of Maryland shall appoint one or more official court reporters for the circuit courts of Calvert, Charles, Prince George's, and St. Mary's Counties, respectively. These reporters each shall be expert stenographers or otherwise competent to record court proceedings. Each shall hold office during the pleasure of the judges of said respective courts. The court reporters or stenographers in Prince George's County shall be paid a per diem to be fixed by the court not to exceed \$40.00 for each and every day of actual service; and the court stenographers for Calvert and St. Mary's Counties shall be paid a per diem to be fixed by the court not to exceed \$40.00 for each and every day of actual service. Each such court stenographer shall be paid such expenses as may be approved by the court payable by the County Treasurer of the county in the circuit court of which such services shall have been rendered, as a part of the court's expenses, upon the presentation of a certificate of the clerk or any of the judges of said courts showing attendance and services of said reporter. However, in Calvert and St. Mary's Counties the court reporter or stenographer shall be paid mileage at the rate of ten cents per mile for all necessary travel between his home and the place of executing his duties as such; and the court reporters or stenographers in Calvert and St. Mary's Counties after having served at least two years in such position shall be granted two weeks vacation with pay which shall be computed from the weekly average of per diem compensation during the year.*

(b) *Said reporters shall attend and take full stenographic notes of, or otherwise record, all oral testimony and judicial opinions in all proceedings in said courts at such times and in such cases as the respective courts may direct. Said reporters shall make and furnish to any party, upon request, a typewritten transcript of any part of said notes, upon payment by such party of the expenses incident to such transcript at a rate to be fixed by the court.*

(c) *The court may, in any case pending in any said courts, direct such reporters to transcribe the notes taken with respect to such case, and the cost thereof at the rates aforesaid shall be taxed as a part of the cost in such case, or if the court shall so direct, be paid as a part of the court expenses.*
