INTRODUCTION OF RESOLUTIONS

House Resolution No. 12—By the Montgomery County Delegation :

House Resolution expressing the deep regrets of the House of Delegates of Maryland over the passing of Mrs. Mollie Davis Nicholson of Montgomery County.

The members of the General Assembly of Maryland have learned with deep regret of the passing of Mrs. Mollie Davis Nicholson at the age of 86.

Mrs. Nicholson was a native of Winchester, Virginia, having been a descendant of one of the first families of the Shenandoah Valley of Virginia. After her marriage to the late Jesse W. Nicholson, an attorney and former Register of Wills of Montgomery County, she moved to Chevy Chase and lived in Montgomery County for more than 50 years.

Mrs. Nicholson had a long, productive, and fruitful life. She organized the National Society of Arts and Letters in 1944 and, also, was closely connected with the Democratic Party as organizer of the Women's Democratic Club of Chevy Chase, the Federation of Montgomery County Women's Democratic Clubs and the Federation of United Democratic Clubs of Maryland.

In 1925 she was the first Democratic National Committeewoman from Maryland.

Later she formed and headed the National Women's Democratic Law Enforcement League and for ten years she edited *The Woman Voter*, a weekly paper.

Her activities also included being president of the National
