The following amendment was offered from the floor by Senators Hall and Steffey:

## Amendments to Senate Bill No. 8

Amendment No. 4—Following line 40 of Section 42E on page 5 of the printed bill, add the following:

“(a-1) Any Senatorial District which is entitled under the provisions of this section to elect more than two Senators shall be divided into subdistricts. Each subdistrict shall elect a number of Senators which shall be not more than two Senators from each subdistrict. If the subdistricting of any Senatorial District has not been accomplished by April 1, 1966, by act of the General Assembly, the Governor of Maryland by proclamation shall forthwith determine the number and boundaries of the subdistricts, but not later than May 1, 1966.”

*Which amendment was read and adopted.*

The following amendment was offered by Senator Mach from the floor:

Amendment No. 5—In Line 19 of Section 42E on Page 4 of the printed bill, after the following: “2 Senators.” add the following:

“The first legislative district is composed of the area within Wards One, Two, Three, Four, and Five; and within the area of Precincts Seven to Fourteen inclusive, in Ward Number Six; and in the area within the Precincts One to Twenty-Nine, inclusive, of Ward Number Twenty-six; and of those portions of Precincts Thirty-seven and Thirty-eight of Ward Number Twenty-six which are situated southeasterly from the center line of Sinclair Lane; and of the area within Precinct Thirty-nine of the Twenty-sixth Ward.”

and in Line 21 following “2 Senators.” add the following:

“The second legislative district is composed of the area within Precinct One to Six, inclusive, of Ward Number Six; and of the area within Ward Number 7; and of the area within Precincts Two and Three and within Precincts Fourteen to Twenty-six, inclusive, in Ward Number Eight; and of the area within Precincts Six to twenty-two, inclusive, of Ward Number Nine; and of the area within Precinct Twenty-five of Ward Number Nine; and of the area within Wards Numbers 10, 11, and 12; and of the area within Precincts One, Two, and Twelve of Ward Number Fourteen; and of the area within Precincts Thirty to Thirty-four, inclusive, of Ward Number Twenty-Six.”
