of Delegates. Nothing in this subsection affects the election, tenure, powers, or duties of Delegates in office at the time these events occur, for the remainder of the terms in which they are then serving. This subsection becomes fully effective when the members of the House of Delegates have been elected in November, 1966, and in November, 1970, and thereafter have qualified for and entered upon their terms of office. This subsection does not apply, and subsections (a), (b), and (c) of this section do apply (if still effective), to elections for members of the House of Delegates in any year after 1970.

42D.

- (a) This subheading prevails to the extent of any inconsistency over Sections 2, 4, 5, 6, 9, and 13 of Article 3 of the Constitution of Maryland.
- (b) This subheading provides for establishing the membership of and for fixing certain districts for representation in the House of Delegates of Maryland, until such time as it is superseded in whole or in part by an amendment to the Constitution of Maryland. With no further action required by the General Assembly, and to the extent of any conflict, this subheading is no longer effective, in whole or in part, as of the effective date of any such amendment of the Constitution of Maryland; except that nothing thereby affects the election, tenure, powers, or duties of Delegates in office at the time these events occur, for the remainder of the terms in which they are then serving.

Senate

42E.

- (a) The membership of the Senate consists of forty-three (43) Senators. The State is divided into sixteen State Senatorial Districts composed and to elect the number of Senators as follows:
 - (1) District 1—Garrett, Allegany, and Washington Counties— 3 Senators.
 - (2) District 2—Frederick and Carroll Counties—2 Senators.
 - (3) District 3—Montgomery and Howard Counties—5 Senators.
 - (4) District 4—Prince George's County—5 Senators.
 - (5) District 5—Charles and St. Mary's Counties—1 Senator.
 - (6) District 6—Anne Arundel and Calvert Counties—3 Senators.
 - (7) District 7—Baltimore City, First Legislative District— 2 Senators.

THE FIRST LEGISLATIVE DISTRICT IS COMPOSED OF THE AREA WITHIN WARDS ONE, TWO, THREE, FOUR, AND FIVE; AND WITHIN THE AREA OF PRECINCTS SEVEN TO FOURTEEN INCLUSIVE, IN WARD NUMBER SIX; AND IN THE AREA WITHIN THE PRECINCTS ONE TO TWENTY-NINE, INCLUSIVE OF WARD NUMBER TWENTY-SIX; AND OF THOSE PORTIONS OF PRECINCTS THIRTY-SEVEN AND THIRTY-EIGHT OF WARD NUMBER TWENTY-SIX WHICH ARE SITUATED SOUTHEASTERLY FROM THE CENTER LINE OF SINCLAIR LANE; AND OF THE AREA WITHIN PRECINCTS THIRTY-NINE OF THE TWENTY-SIXTH WARD.
