provided by the department: (1) the gross amount of the contributions pledged or collected; (2) the amount thereof given or to be given to the charitable purpose represented; (3) the aggregate amount paid and to be paid for the expense of such solicitation; and (4) the aggregate amount paid to and to be paid to professional fund raisers and solicitors. In addition, the department may require that within 90 days after the close of any special period of solicitation the charitable organization conducting such solicitation shall file a special report of the information specified in this section for such special period of solicitation.

EVERY CHARITABLE ORGANIZATION SUBJECT TO THE PROVISIONS OF THIS SUBTITLE SHALL KEEP A FULL AND TRUE RECORD IN SUCH FORM AS WILL ENABLE SUCH CHARITABLE ORGANIZATION ACCURATELY TO PROVIDE THE INFORMATION REQUIRED BY THIS SUBTITLE. ALL RECORDS REQUIRED HEREUNDER SHALL BE OPEN TO IN-SPECTION AT ALL TIMES BY THE DEPARTMENT, AND UPON DEMAND SHALL BE PRESENTED TO THE DEPARTMENT FOR INSPECTION. THIS SUBTITLE SHALL NOT APPLY TO SOLICITATIONS CONDUCTED BY OR ON BEHALF OF RELIGIOUS CORPORATIONS, MUNICIPAL CORPORATIONS, HOSPITALS, VOLUNTEER FIRE COMPANIES, FIRE AND PO-LICE DEPARTMENTS AND ANY CHARITABLE ORGANIZA-TION WHICH IS A MEMBER OF ANY COMMUNITY CHEST OR UNITED FUND ORGANIZED AND EXISTING UNDER THE CORPORATION LAWS OF THE STATE OF MARYLAND TO THE EXTENT THAT FUNDS DERIVED FROM SUCH SOLICITA-TIONS ARE REPORTED BY THE COMMUNITY CHEST OR UNITED FUND BUT FUNDS DERIVED FROM SOLICITATION NOT SO REPORTED SHALL BE REPORTED AS OTHERWISE HEREIN REQUIRED. THIS SUBTITLE IS NOT TO APPLY TO ANY CHARITABLE ORGANIZATION WHICH DOES NOT ACTUALLY RECEIVE CONTRIBUTIONS IN EXCESS OF TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) DURING ANY CALENDAR PERIOD, PROVIDED ITS FUND-RAISING FUNCTIONS ARE CARRIED ON BY PERSONS NOT PAID FOR THE PROPERTY OF TH THEIR SERVICES AND PROVIDED NO PART OF THE ASSETS OR INCOME OF THE CHARITABLE ORGANIZATION INURES TO THE BENEFIT OF OR IS PAID TO ANY OFFICER OR MEM-BER OF SUCH ORGANIZATION.

SEC. 2. And be it further enacted, That this Act shall take effect June 1, 1966.

CHAPTER 640

(House Bill 302)

AN ACT to repeal and re-enact, with amendments, Section 701(a) of Article 66C of the Annotated Code of Maryland (1957 Edition), title "Natural Resources," subtitle "Oysters and Clams," to change
