(D) TWO SENATORS SHALL BE RESIDENTS OF AND ELECTED FROM LEGISLATIVE SUB-DISTRICT NO. 4C, WHICH SHALL CONSIST OF THOSE ELECTION DISTRICTS HEREINBEFORE DESCRIBED IN SAID SUBTITLE AS NOTTINGHAM-NO. 4, PISCATAWAY-NO. 5, SPAULDINGS-NO. 6, AQUASCO-NO. 8, SURRATTS-NO. 9, BRANDYWINE-NO. 11, OXON HILL-NO. 12, AND SEAT PLEASANT-NO. 18.

SUB-DISTRICTS FOR THE HOUSE OF DELEGATES

(A) PRINCE GEORGE'S COUNTY IS DIVIDED INTO LEGISLATIVE SUBDISTRICTS FOR ITS DELEGATION IN THE HOUSE OF DELEGATES OF MARYLAND, AS IN THIS SECTION PROVIDED.

(B) THREE MEMBERS SHALL BE RESIDENTS OF AND ELECTED FROM LEGISLATIVE SUB-DISTRICT NO. 4A, AS HEREINBEFORE DESCRIBED IN SECTION 46(B).

(C) SEVEN MEMBERS SHALL BE RESIDENTS OF AND ELECTED FROM LEGISLATIVE SUB-DISTRICT NO. 4B, AS HEREINBEFORE DESCRIBED IN SECTION 46(C).

(D) SIX MEMBERS SHALL BE RESIDENTS OF AND ELECTED FROM LEGISLATIVE SUB-DISTRICT NO. 4C, AS HEREINBEFORE DESCRIBED IN SECTION 46(D).

(E) THE BOARD OF ELECTION SUPERVISORS FOR PRINCE GEORGE'S COUNTY MAY DESIGNATE THE ABOVE-DESCRIBED LEGISLATIVE SUB-DISTRICTS 4A, 4B, AND 4C AS PRINCE GEORGE'S COUNTY LEGISLATIVE DISTRICTS 1, 2, AND 3 RESPECTIVELY.

SEC. 2. *And be it further enacted*, That this act is hereby declared to be an emergency measure and necessary for the immediate preservation of the public health and safety and having been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, the same shall take effect from the date of its passage.
