- to advocating or opposing any present or prospective political candidacy, or to advocating or opposing any legislation currently being considered or prepared. THE FACILITIES MUST BE USED IN COMPLIANCE WITH THE RULES AND REGULATIONS OF THE FEDERAL COMMUNICATIONS COMMISSION.
- (b) The Advisory Committee COMMISSION on Educational Television is created with eleven members to be appointed by the Governor. From time to time the Governor shall designate one person to be Chairman and another to be Vice-Chairman of the Advisory Committee COMMISSION.
- (c) Of the persons first appointed to the Advisory Committee COMMISSION, three shall be appointed for terms of five years; three, for four years; three, for three years; and two, for two years. As these initial appointments expire all appointments shall be for terms of five years. A member whose term is expiring may be reappointed to another term. Vacancies shall be filled from time to time for the remainder of the term left vacant.
- (d) The members of the Advisory Committee COMMISSION shall be chosen from residents of Maryland who are distinguished for being able, conscientious, intelligent, and public spirited. They shall be broadly representative of the State as a whole, and shall include persons especially skilled in such fields as public or private education, libraries, ART, MUSIC, DRAMA, HIGHER EDUCATION, the television and radio industries, public relations, or other eategories chosen by the Governor to bring special competence or general intelligence and representation to the Committee's COMMISSION'S membership. OF THOSE APPOINTED TO THE ADVISORY COMMITTEE, ONE MEMBER SHALL BE CHOSEN FROM THE SENATE OF MARYLAND AND ONE MEMBER SHALL BE CHOSEN FROM THE HOUSE OF DELECATES OF MARYLAND.
- (e) The Committee COMMISSION shall serve in an advisory capacity to the State and local Departments of Education, as to all phases of State, regional, and local educational television facilities and programs to or for which State funds are appropriated. It shall provide counsel and advice for the development and management of the educational television facilities and programs, and shall seek to assure a wise and effective use of these facilities and a series of programs which will contribute to the educational, cultural, and esthetic life and values of the residents of this State AND SHALL APPROVE ALL NON-INSTRUCTIONAL PROGRAMS FOR THE GENERAL PUBLIC AS SPECIFIED IN SUBSECTION (A) OF THIS SECTION.
- (f) Members of the Advisory Committee COMMISSION shall not receive compensation for their memberships on the Committee COMMISSION, but they may be reimbursed for necessary and proper expenses incurred in their attendance at meetings and in the discharge of their duties as members of the Committee COMMISSION.
- (C) THE PROGRAM DIRECTOR OR CHIEF ADMINISTRATOR UNDER THIS SECTION SHALL BE APPOINTED FROM TIME TO TIME BY THE STATE DEPARTMENT OF EDUCATION SUBJECT TO THE ADVICE AND CONSENT OF THE ADVISORY COMMISSION.
